1. Community Improvement Grant update

Community Engagement Staff updated the CAB on the two most recently completed Community Improvement Grant projects: 2018 MLK Juneteenth Festival and Unshackled. In addition, Staff provided an update on the 2017-2018 CAB grant application appeals. The new hearing date is scheduled for Septemeber 4, 2018.
