10.1\* JESSIE'S COTTAGES - TENTATIVE PARCEL MAP AND CONDITIONAL USE PERMIT - 1124 RUSSELL AVENUE - PRJ17-025; CUP17-022; MIN16-001

> BACKGROUND: The project is a request for a tentative parcel map with a residential small lot subdivision conditional use permit to create three lots, two of which would be less than 6,000 square feet on a vacant 0.41 property. All three lots would be developed with a single-family dwelling and an accessory dwelling unit. A shared 20-foot wide driveway would provide access to the new dwellings.
