The Cultural Heritage Board shall consider the following matters, standards, guidelines and criteria to the extent applicable, in determining whether to grant or deny a permit. Whether the proposed change is consistent or incompatible with the architectural period of the building. Whether the proposed change is compatible with any adjacent or nearby landmark structures or preservation district structures. Whether the colors, textures, materials, fenestration, decorative features and details proposed are consistent with the period and/or are compatible with adjacent structures. Whether the proposed change destroys or adversely affects an important architectural feature or features. The Secretary of the Interior's Standards for Rehabilitation and Guidelines for Rehabilitating Historic Buildings. Such other matters, criteria and standards as may be adopted by resolution of the Cultural Heritage Board. (Ord. 2668 § 1, 1988)

6.1 PUBLIC HEARING - LANDMARK ALTERATION - MCDONALD AVE -1120 MCDONALD AVE. - FILE NO. LMA18-013 BACKGROUND: Application for landmark alteration to for front façade changes including the addition of a faux dormer, repair and expansion of the entry landing and stairs, and the addition of a front fence. Project Planner: Murray

Senior Planner Susie Murray gave the Staff Report.

Project Applicant and Architect gave a brief presentation and answered Board questions.

A motion was made by Board Member McHugh, seconded by Board Member Galantine, to waive reading of the text and adopt as amended RESOLUTION NO. 328 ENTITLED: RESOLUTION OF THE CULTURAL HERITAGE BOARD OF THE CITY OF SANTA ROSA APPROVING A LANDMARK ALTERATION PERMIT FOR EXTERIOR MODIFICATIONS TO THE FRONT FACADE, FOR THE PROPERTY LOCATED AT 1120 MCDONALD AVENUE, WHICH IS WITHIN THE MCDONALD PRESERVATION DISTRICT; ASSESSOR'S PARCEL NUMBER 180-460-056; FILE NUMBER LMA18-013 with the following conditions:

The faux dormer installed shall not penetrate the structure. There shall be no evidence of disturbance to the historic fabric of the house outside twelve (12) inches of the footprint of the dormer.

The shingles located on the faux dormer shall be similar to but differentiated from the existing shingles (i.e. different coursing or size of shingle).

A hand-railing appropriate to the era of the two architectural styles represented in the historic structure shall be shown on the plans submitted for building permits. Plans submitted for building permits shall include a signed letter from a qualified architectural historian stating that the design

#### of the handrail shown on the plans is appropriate for the era of the two architectural styles of the house
