1. CALL TO ORDER

Chair Gow called the meeting to order at 4:02pm.

3. PUBLIC COMMENTS

Duane De Witt advocated for more land and services for the Roseland area and identified possible funding sources.

4. APPROVAL OF MINUTES

4.1 March 27, 2019 Regular Meeting Minutes

The minutes from the March 27th meeting of the BOCS were approved as submitted.

5. REPORTS ON ACCOMPLISHED AND UPCOMING EVENTS

Interim Director Kelley Magnuson reported on accomplished events, including the Senior Expo, Recreation Sensation Camp registration, Crossing the Jordan fundraiser at De Turk Round Barn, the teen Work Experience program and adult summer softball registration. Additionally, the Finley Center is having new flooring installed in phases. Upcoming events include Rosie the Trolley participation in the Pride Parade, summer staff in-service, the start of summer day camps and adult softball games, the Strawberry Moon belly dance show, a senior membership drive and Rosie the Trolley tours at the Wednesday Night Market. **Board of Community Services**

6. DIRECTOR UPDATES

City Council approved the Coffey Park Master Plan on April 2nd and construction is scheduled for winter 2019. Public review of the Kawana Springs Community Park environmental documents is complete. The environmental declaration and Master Plan are scheduled for Council approval later this summer.

Magnuson provided information about the plan for realignment of the Recreation and Parks Department. Park maintenance and park planning will move under Transportation and Public Works (TPW), recreation programs will merge with Office of Community Engagement (OCE), which includes the Violence Prevention Partnership programs. The consolidation of community programs and engagement will fall under the Planning and Economic Development Assistant City Manager. BOCS should not be impacted by this change.

7.1 VOLUNTEER PROGRAM

Recreation Supervisor Jeff Tibbetts will provide an overview of the volunteer program, including Park-a-Month and other volunteer opportunities.

Recreation Supervisor Jeff Tibbetts thanked Elaine Gutsch, the Recreation Coordinator who strengthened the Volunteer program before he took over. Tibbetts highlighted City volunteer programs like MLK Day, Arbor Day, Park-a-Month, Adopt-a-Green Space, Crafts Fair, Fairy Tale Ball, Junior Giants, Senior Expo and Oktoberfest. Community organized volunteering events include work at the Rural Cemetery, Luther Burbank Home and Gardens, Northwest Park Pump Track, Youth Park Train, Fly Fishing Pond, Community Gardens and many more sites. School groups, Scouts, organizations, churches and businesses are all part of our City volunteer program. Volunteers may email volunteer@srcity.org or srcity.volunteerhub.com

7.2 RECREATION PROGRAMS - SUMMER HIGHLIGHTS Recreation programs will be highlighted, including camps, work experience, sports clinics, softball, senior programs, aquatics, classes and much more.

Recommended Action: Information

Recreation Supervisor Amy Rocklewitz highlighted recreation programs, including summer day camps which this year already have over 2,000 campers registered. Also highlighted were the work experience program serving over 300 teens, youth sports clinics, adult summer softball/sports field allocations and senior programs. Rocklewitz also emphasized the Neighborhood Services programs, including Recreation Sensation, Leaders-in-Training work experience program, Junior Giants baseball serving 300 youth ages 5-13, Teen Gym Basketball and a family fun evet called Splash Bash.

Recreation Supervisor Don Hicks reported on Aquatics events at the Ridgway and Finley pools. Recreation swim and rentals attract 48,000 guests to our pools, in addition to over 24 camp and family groups and 200 pool rentals and birthday parties. We are the Northern California primary resource for lifeguard training. Vamos a Nadar is supported in part by scholarships and teaches 5,000 Hispanic youth how to swim. A new spray ground at the Finley Pool is anticipated in 2020.

Recreation Supervisor Jeff Tibbetts provided an overview of Howarth Park Operations, including boating, sailing, and horsemanship camps and Barnyard Adventures and pony rides. Other activities include Animal Vet camp, Tennis and Engineering camps, Art & Crafts, Yoga, Dance & Tiny Tots. We also offer off-site camps including volleyball, gymnastics, KidScience, soccer and Cloverleaf Camp.
