The CAB decided to have each member submit their biographies to staff and staff would upload all photos and biographies to the CAB website. Staff also offered to take headshots of members that do not have photos to submit. Staff will send out a due date to the CAB in the next CAB Weekly Update.

Linda Sheehan suggested that members add a link to their social media accounts to their biographies.

The Empowerment Subcommittee led the CAB through an activity on neighborhood and community groups, as well as other types of groups. Member Chaparro provided the CAB with a background on the Empowerment Subcommittee and what work they are focusing on in their work plans. Each CAB Member and staff had an opportunity to describe what the term empowerment means to them:

- 13. Creating pathways and space. Trust and equity. Giving people the tools.

Vice Chair Harper then asked Members to brainstorm different groups that the CAB could potentially reach out to and/or attend their meetings. The CAB then broke into groups to share their groups and come up with a few more. Each group then shared a few examples of what was brainstormed. The Empowerment Subcommittee collected all post-it notes and will put together a list based off of what was brainstormed.
