Trim at top of steeple shall match existing church trim; 3. Steeple shall be solid on 3 sides at the base of the structure, with the opening at the east side, facing the existing church building; 4. Consider planting a perimeter landscape buffer surround; 5. Consider charcoal grey for screens and doors; 6. Consider matching accent vertical elements to existing trim color of the church.
