Whether the colors, textures, materials, fenestration, decorative features and details proposed are consistent with the period and/or are compatible with adjacent structures. Whether the proposed change destroys or adversely affects an important architectural feature or features. The Secretary of the Interior's Standards for Rehabilitation and Guidelines for Rehabilitating Historic Buildings. Such other matters, criteria and standards as may be adopted by resolution of the Cultural Heritage Board. (Ord. 2668 § 1, 1988)

6.1 LANDMARK ALTERATION - AVENUE 320 CONCEPT REVIEW 320 COLLEGE AVENUE - FILE NO. LMA19-002

The AVENUE 320 project proposal includes (1) redevelopment of the existing structure into a 20-unit multifamily apartment building and (2) construction of a new 20-unit multifamily apartment building fronting Lincoln Street. The unit mix will consist of Studio (3), 1-Bedroom (22), and 2-Bedroom (15) units. All units will be market-rate rental units. Planner: Trippel

## 6.2 LANDMARK ALTERATION - ECONO INN REDEVELOPMENT CONCEPT REVIEW

502 SANTA ROSA AVENUE - FILE NO. LMA19-003

The Econo Inn Redevelopment project proposal includes re-use of an existing structure and new construction to create a 60-room hotel mixed-use project comprised of 1-, 2-, and 5-story buildings. The existing single-story hotel structure is expanded to include 1- and 2-story hotel rooms with private terraces and an interior courtyard with event pavilion. A new 5-story building fronts Santa Rosa Avenue and features a ground floor hotel lobby and retail spaces with hotel rooms and event and gallery spaces on multiple floors and a rooftop terrace. Planner: Trippel

City Planner Andrew Trippel gave the Staff Report and a brief presentation.

Eric Anderson, Principle of Urban Green Entities and part of the applicant team spoke about the project. Urban Green Entities have entered into contract to purchase the property.
