# 5. PUBLIC COMMENTS ON NON-AGENDA MATTERS

Eris Weaver, Executive Director of the Sonoma County Bicycle Coalition stated she had trouble logging into the Board's Zoom meeting today; she is happy about the recruitment for the Active Transportation Planner and sharing information with potential applicants; she noticed issues with the bicycle striping completed after the slurry seal project and has addressed this with the project manager; she reminded the Board that September is Bike to Wherever Month and Bike to Wherever Day will be on the 24th with giveaways available at various vendors; she has asked for advanced notice if the Santa Rosa Creek Trail is going to be closed so that can be communicated to their members, and this is not happening; and she is looking for a debriefing of the Fourth Street workshop.

# 6.1 REPORT - Vice Chair Election

BACKGROUND: The Board shall elect a Vice Chair to serve a one-year term.
