The new monitoring on all waste water treatment plants must be done for the influent, effluent, and biosolids. PFAS. Director Burke also noted that 2020 was quite a challenging year. She expressed appreciation for the leadership and support of the Board and for the creative and adaptive work of department staff as they continued to serve our community.
