#### 6. SCHEDULED ITEMS

6.1 CONTINUED PUBLIC HEARING - DOWNTOWN STATION AREA SPECIFIC PLAN DESIGN GUIDELINES AND ZONING CODE CONSISTENCY AMENDMENTS - FILE NO. ST20-002 (CONTINUED FROM OCTOBER 15, 2020)

BACKGROUND: Following consideration of an update to the Downtown Station Area Specific Plan (DSASP) by the City Council in October 2020, Section 2 of the Design Guidelines covering the Downtown Station Area are proposed to be updated to (1) reflect new guidelines from the DSASP, (2) remove design concepts addressed by the standards of the DSASP, and (3) eliminate redundancy and overlap that exists in the 2002 document. The proposed Zoning Code amendments

seek to: (1) implement the design standards of the DSASP, (2) update the Historic Combining District with additional preservation district character defining elements, and (3) modify the Landmark Alteration and Design Review process.

Presenter: Amy Nicholson, Senior Planner

Senior Planner Amy Nicholson gave the staff presentation.

Chair Kincaid opened the public hearing at 6:09 pm.

Greg Parker - Expressed concerns about the maps, and asked that staff make sure the maps correspond with past agreements, and show accurate transition zones.

Roy Loessin - Expressed concerns regarding misunderstandings of how FAR (floor area ratio) affect the 12 contributing properties on B Street. The 12 properties have historic and architectural value. Asked that staff reach out more to neighbors in the St Rose District, as this process is very complicated. The general neighborhood feeling is that the proposed changes will declaw the Cultural Heritage Board as far as development in the neighborhood.

Pamela Roberts - Requested more outreach from the boards because of the complex issues. The St. Rose district has been inundated with homeless services; Catholic Charities, Caritas Village (where a block of buildings are being torn down) and Hotel Azura. Wants the neighbors to be able to speak more with Design Review Board and Cultural Heritage Board to work through this together.

Chair Kincaid closed the public hearing at 6:18 pm.

Senior Planner Amy Nicholson clarified transition area information on the maps.

Andrew Hill (consultant) responded to Board questions regarding bicycle plan (bike lanes.)
