3. STUDY SESSION

3.1 SANTA ROSA POLICE DEPARTMENT STAFFING

Staff will provide a department-wide analysis of the historical staffing trends, including staffing within the investigative units and special assignments. The study will include fifteen years of historical data of overall staffing and calls for service. Staff will also provide an update on current recruitment efforts and succession planning.

Police Chief Ray Navarro presented and answered questions from Council.

Elizabeth Escalante, Commissioner on the Commission of Human Rights, spoke echoing the comments of previous speakers asking for the report be brought to the Council, asked that vulnerable communities not be asked to participate in another listening session, and the need to build trust with the police.

Craig spoke thanking Chief Navarro and School Resource Officers for the work they do.
