Kimberly Zunino presented the Fiscal Year 2020-2021 Budget and gave an overview of annual flows and Operations and Maintenance (O&M) projects. Ms. Zunino discussed budget reduction measures, and provided an overview of the 5 year Capital Improvement Program. Ms. Zunino provided an overview of estimated regional miscellaneous revenue and information on the refund reserve. Committee Members agreed to hold a Special Subregional Technical Advisory Committee meeting to further discuss the amount of fund balances each Subregional Partner wants to contribute.

Lori Urbanek gave a summary of the 20-year Capital Improvement Program. Ms. Urbanek discussed the 20-Year spending needs for the Regional Water Reuse System.

Tonya Mokvyts presented the 2021-2022 proposed CIP Regional project highlights including: emergency generator fuel tank replacement, Laguna Treatment Plant electrical infrastructure replacement, aeration basin and aeration header improvements, and maintenance building roof improvement.
