8.1 REPORT - Code Enforcement Presentation

8.3 CONCEPT LMA - NEW SFD - Not a Project - LANDMARK ALTERATION - 912 MCDONALD AVE - LMA22-018 (PRJ22-027)

> BACKGROUND: Concept Landmark Alteration Permit to Construct a new 1,873 sf single-family dwelling with three bedrooms, 2.5 bath, with a detached 648 sf two-car garage, 98 sf well pump house, and 500 sf covered outdoor area. This home is located in the McDonald Preservation District.
