BACKGROUND: The proposed action will authorize submission of the 2020-2024 Consolidated Plan and the Fiscal Year 2020/2021 Action Plan (Plans) to the U.S. Department of Housing and Urban Development (HUD), as well as approve grant agreements for public services, fair housing, and Housing Opportunities for Persons with AIDS (HOPWA) programs. HUD requires submission of the Annual Action Plan and the Consolidated Plan so that the City can receive federal housing and community development funds in the form of Community Development Block Grant (CDBG), HOME Investment Partnership Act (HOME), and Housing Opportunities for Persons with AIDS monies.

RECOMMENDATION: It is recommended by the Housing & Community Services Department that the Council, by resolution: (1) authorize submission of the 2020 - 2024 Consolidated Plan and the Fiscal Year 2020/2021 Action Plan to the U.S. Department of Housing & Urban Development (HUD); (2) approve the Fiscal Year 2020/2021 Grant Agreements for public services, fair housing, and Housing Opportunities for Persons with AIDS (HOPWA) funds in the amount of \$698,633; (3) authorize the Director of Housing and Community Services to execute the Grant Agreements and any future amendments thereto for public services, fair housing, and HOPWA; and (4) authorize the City Manager to execute the annual federal funding agreements with HUD and any additional forms or documents required by HUD to implement the 2020 - 2024 Consolidated Plan and the Fiscal Year 2020/2021 Action Plan.
