DR17-006 BACKGROUND: This project proposes development of a new, four-story medical office building with 92,000 sq ft of floor area and an associated 6-level, 600-stall parking structure. The project includes a Conditional Use Permit for operation of a parking facility and increased building height in a commercial district.
