BACKGROUND: The Caritas Village project includes the redevelopment of a city block into a comprehensive family and homeless support services facility (Caritas Center) to be operated by Catholic Charities; and, a 126-unit affordable housing development (Caritas Homes) to be operated by Burbank Housing. The City Council previously certified the Caritas Village Environmental Impact

Report and adopted a Statement of Overriding Considerations and Mitigation Monitoring and Reporting Plan for the project on March 3, 2020, pursuant to the California Environmental Quality Act. At a joint meeting, the Cultural Heritage Board and Design Review Board will consider the following: 1) Design Review Board consideration and approval of a parking reduction; 2) Design Review Board consideration and approval of Preliminary Design Review; 3) Cultural Heritage Board consideration and approval of a Major Landmark Alteration to allow for demolition of the existing Catholic Charities facilities and residential buildings on the project site, and new construction within the St. Rose Historic Preservation District; 4) Cultural Heritage Board consideration and approval of interpretive materials related to the history of the property as well as the broader St. Rose Historic Preservation Historic District; 5) Cultural Heritage Board consideration and approval of a gateway monument on the north side of the intersection of 7th and A Street and historic urban sidewalk treatments and historic benches.
