	<ul> <li>emergency orders, Congress enacted the Emergency Paid Sick Leave Act requiring certain</li> <li>employers provide employees COVID-related paid sick leave in March 2020. On July 7, 2020, Counci</li> <li>adopted urgency ordinance ORD-2020-006 adding Chapter 10-47 to the Santa Rosa City Code to</li> <li>address some of the gaps in the federal law. Both the federal law and City ordinance expired</li> <li>December 31, 2020. This new urgency ordinance would replace the expired Chapter 10-47 and</li> <li>require that employers provide COVID-related paid sick leave benefits similar to those previously</li> <li>required by federal law and the now expired City ordinance. This new urgency ordinance would be</li> <li>effective upon adoption through March 31, 2021. Under the City Charter, five affirmative votes are</li> <li>necessary to adopt an urgency ordinance.</li> <li>RECOMMENDATION: It is recommended by the Economic Development Subcommittee that Council</li> <li>adopt an urgency ordinance to require employers to provide COVID-related paid sick leave benefits</li> </ul>					
	through March 31, 2021, to replace the expired ORD-2020-006 previously adopted by Council.
