Mme. Mayor Rogers, Vice-mayor Stapp, Councilmember MacDonald, and all Council members:

I'm a Northeast Santa Rosa resident of District 3, writing to commend your restraint in avoiding the fraught path other municipalities have taken in response to impassioned protests about violence in the Middle East, particularly the pain afflicting Palestinians, Israelis, and Americans connected to the war by family or a caring heart.

I am concerned that unnecessary divisions would be caused by inserting Santa Rosa into a thorny geopolitical conflict. You likely know of the anguished statement by SF Mayor Breed who wrote on January 19th, "Since the Board of Supervisors introduced their Gaza ceasefire resolution...our City has been angrier, more divided, and less safe." She continued, "I cannot watch us divide ourselves even more. A leader, like a doctor, should be guided by the basic ethos to 'do no harm,' to not make a bad situation worse."*

I don't mean to be coy. I have views about the conflict that are in line with my values as an American committed to the success of democratic government and my identification as a Jewish member of the Santa Rosa community. In my congregation, Shomrei Torah, we frequently recognize that each precious human life on earth is in the image of its creator, underscoring the fundamental error of violence among humans.

I also have political views on how Israel should conduct a war brought on by the savage 7 October cross-border attack, about the unspeakable ongoing hostage situation, about the suffering, death and injury of a great number of Gazans and Israelis, and numerous other related issues that trouble me and so many others.

But my emotional, political, moral, and philosophic responses are for another forum, not the City Council of Santa Rosa.

Thanks for your caring and work for our city.

Dear City Council Members

I urge you to continue to refuse to consider a resolution calling for an immediate Gaza ceasefire. Nobody wants to see civilians killed, but a call for an immediate ceasefire will not save lives in the long run. There was a ceasefire in place on October 7 before over 2000 Hamas terrorists launched their barbarous invasion. Their goal was to kill as many Israeli civilians as possible and their own videos show them hunting Israeli's in their homes. Hamas' leaders have stated that their exploits of October 7 will be repeated over and over again until Israel is destroyed. They absolutely refuse a political solution. As a descendent of Armenian genocide survivors, I can speak to the resulting pain that lives on for generations. The atrocities unfolding in Gaza and the West Bank have resulted in unconscionable death, but our hearts should also mourn the pain that is going to live on for generations.

Collective unmetabolized trauma results in hatred and fear. How else do you explain the justification of war crimes and Israeli's sitting at the crossing denying critical aid to starving humans? The Israeli Minister of Social Equity recently stated "I am personally proud of the ruins of Gaza and that every baby even in 80 years from now will tell their grandchildren what the jews did." This is not the world we should be creating for our children.

The Press Democrat recently stated you all thought this is too nuanced to pass a resolution. Over 17,000 orphans resulting from these merciless attacks. Over two million people are facing displacement, starvation, unsanitary conditions, and preventable diseases. Israel has killed around 15,000 children and in sum nearly 30,000 humans, not counting those under the rubble. 150 women are giving birth each day in tents, many of whom having c-sections without anesthesia. Newborns are malnourished, parents watching helplessly as they die. John's Hopkins predicts 75000 people will have been killed in a matter of 6 months. We. are. funding this. There is nothing complicated or nuanced about that - you are overlooking the simplicity and indisputable human suffering here. We should not be hardened to each other's pain so much so we deny our shared humanity and fail to act.

Those opposed to a ceasefire believe that prolonging the bombings will eradicate resistance. Resistance will always arise if oppression continues. The root of this needs to be addressed. This war has already failed and continuing it is futile. Diplomacy with dignity and liberation are the only way through this. Solutions and healing cannot begin until a permanent ceasefire takes place. Any aid to Israel should be conditional upon their obedience to internationally recognized rules of war and should not be engaged in human rights violations.

This weekend Air Force member Aaron Bushnell self-immolated in front of the Israeli Embassy in Washington DC. They lit themselves on fire because the atrocities in Gaza are not something they could be a part of. A responding police officer, rather than retrieving a fire extinguisher, pointed a gun at them, perfectly illustrating this country's moral bankruptcy.

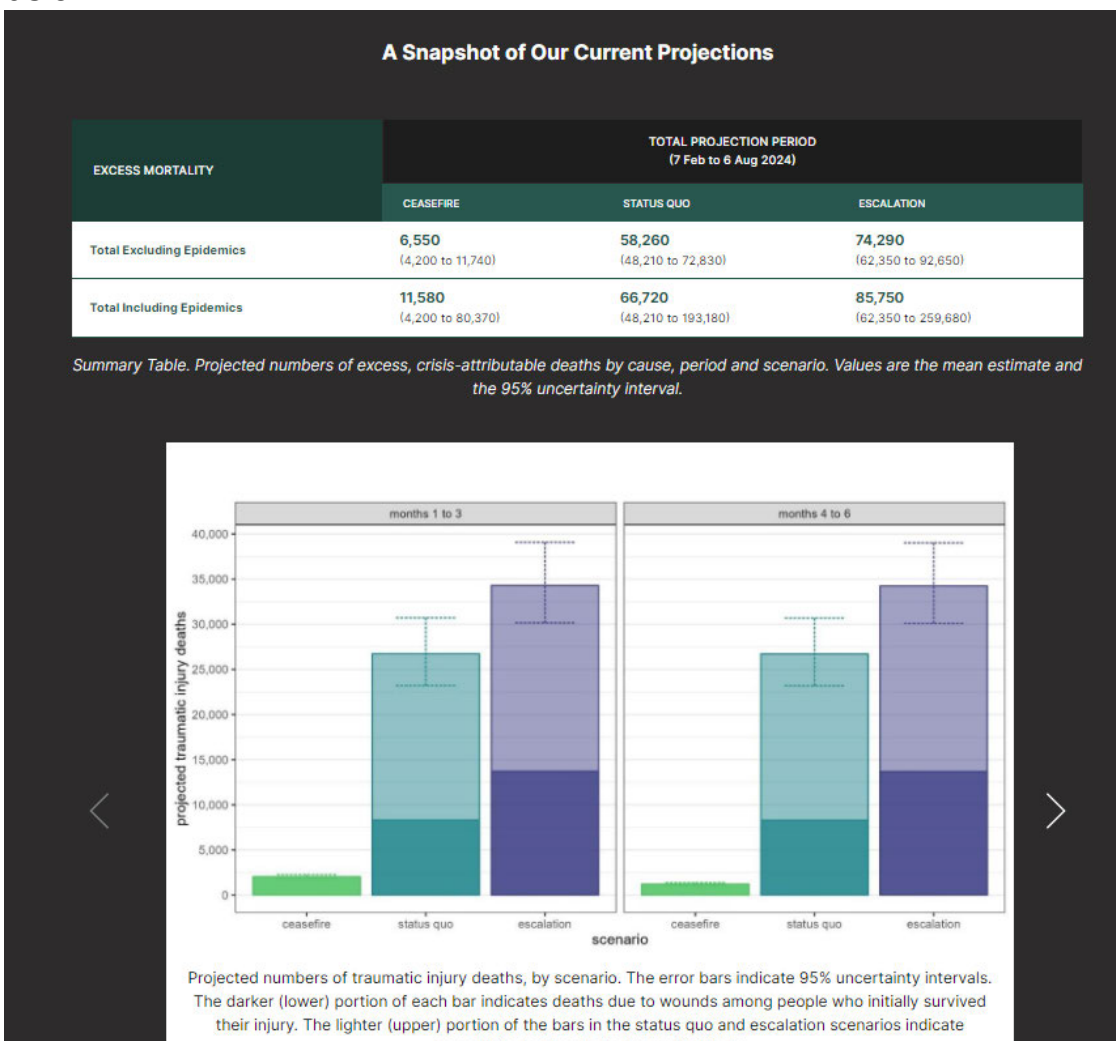

Dear Honorable Mayor and Council Members,

As you know, today is day 143 of the ongoing genocide in Gaza. John Hopkins Center has released projections that show a ceasefire is the only way to save lives. I encourage you to read the report at <https://gaza-projections.org/> and have provided a snapshot of these telling projections below.



Further, I urge you to follow the guidance adopted by the County of Sonoma Commission on Human Rights and pass an immediate ceasefire resolution. The body of the letter published by CHR reads as follows:

"In light of the severe human rights violations occurring in Gaza, Palestine, and Israel, the Sonoma County Commission on Human Rights extends this appeal to all parties involved and affected community members. Acknowledging that the impact of armed conflict reverberates through generations, we understand that healing begins with a collective commitment to ending violence in all its forms. As a nation with a long legacy of violence, including slavery and the genocide of Indigenous Peoples, that evolved to comprise many people from around the world who also experienced genocide and acts of inhumanity, we understand that international conflicts impact us here at home and within our local communities. The Sonoma County Commission on Human Rights calls upon all conflicting parties to unite in building bridges between communities, championing protections for all humans, regardless of any descriptor, and advocating for an end to armed conflicts worldwide.

"Not everything that is faced can be changed, but nothing can be changed until it is faced." - James Baldwin.

We condemn war, genocide, and terrorism. We recognize we cannot stop this as divided communities. International Humanitarian Law provides a set of rules that seek, for humanitarian reasons, to limit the effects of armed conflict. International Humanitarian Law is made up of treaties including the Geneva Conventions, which imposes limits on the means and methods of warfare and protects persons who do not, or no longer, take part in the fighting (including civilians, journalists, medics, aid workers, wounded, sick and stranded troops, prisoners of war or other detainees). The Geneva Conventions emphasize a moral and ethical obligation to protect innocent lives during conflicts.

The Sonoma County Commission of Human Rights recognizes the imperative need for adherence to the principles outlined in the Geneva Conventions, and urges all sides to safeguard the lives of innocent people, including those who have chosen to lay down their weapons. It is our sincere belief that advocating for the protection of non-combatants is a shared responsibility transcending borders, fostering a global commitment to ethical conduct. We condemn all terrorists. We call for the release of all hostages. We call for a ceasefire. The only way to find the beginnings of peace is through a ceasefire - a suspension of fighting so that peace talks may take place and

humanitarian aid can reach those in need.

Only through collective action can we declare "enough is enough" and strive for a future marked by peace, love, and healing for all. The Sonoma County Commission on Human Rights acknowledges and condemns the rise of white nationalism, racism, anti-semitism, Islamophobia, and anti-Arab violence locally and throughout our nation. We call upon our community to build bridges of peace, love, and healing locally. Let this appeal be a beacon guiding us toward a shared commitment to humanity."

Unfortunately, I cannot attend the meeting in person tonight. I want you to know that I firmly believe it is our moral obligation to do all that we can to end the violence and ongoing tragedy in Gaza and the occupied Palestinian territories. Please, I am begging you to do all that you can to save lives. YOUR SILENCE IS VIOLENCE.

Hello Santa Rosa City Council:

My name is Gillian Stewart, and I am a Santa Rosa resident living in District 5. I am writing today to urge the council to pass a Ceasefire resolution, which American citizens overwhelmingly favor. The citizens of Gaza are facing a humanitarian crisis. Months of bombardment at the hands of Israeli Occupation Forces have displaced millions and forced many Palestinians into the southernmost point of Rafah, where they now face the threat of a ground invasion. I attended tonight's city council meeting virtually, and while many opposed to a ceasefire resolution wish to believe those in favor of one are in the minority, 33 of the 36 people who spoke during public comment this evening were IN FAVOR of passing a ceasefire resolution. I know some may believe this is not a local issue, but there are Palestinians living in Santa Rosa, there are anti-Zionist Jews living in Santa Rosa, and every member of Santa Rosa who pays taxes is participating in the funding of the genocide being committed against the Palestinian people. This IS a local issue, and your constituents are paying attention to the voices meant to represent us as we approach an election cycle.

I am disheartened by the city council's inaction thus far, but it is not too late to make the right choice and put a ceasefire resolution on the agenda. Bringing it to a vote, even if it does not pass, will at least let your constituents know where their elected representative honestly stands on the decades long war against the Palestinian people, which did not, as many would like to believe, start on October 6th.

You have the opportunity to stand on the right side of history. I implore you to take it.
