SUBJECT: APPROVAL OF HOMELESSNESS PREVENTION PILOT

PROGRAM - KEEP PEOPLE HOUSED (KPH) - SONOMA FOR

FY 2024/2025 AND FY 2025/2026

AGENDA ACTION: REPORT

RECOMMENDATION

It is recommended by the Housing and Community Services Department that the Council, by resolution: 1) approve and authorize the Director of Housing and Community Services to negotiate and execute, subject to approval as to form by the City Attorney a) an Agreement between the City of Santa Rosa, the County of Sonoma, and the City of Petaluma for the Funding of a Homelessness Prevention Pilot Program (Keep People Housed (KPH) – Sonoma) for Fiscal Years 2024/2025 and 2025/2026 (Funding Agreement) in the amount of \$1.3 million, and b) a Grant Agreement for Keep People Housed (KPH) – Sonoma with the Committee on the Shelterless (Grant Agreement) in the amount of \$1.3 million for the period October 1, 2024 to June 30, 2026; and 2) endorse All Home's Regional Action Plan 2024 as part of its technical and financial support for the pilot program.

EXECUTIVE SUMMARY

All Home, a Bay Area nonprofit organization, has offered to expand its homelessness prevention model into Sonoma County and provide technical assistance and a financial match to support the proposed pilot program, Keep People Housed (KPH) – Sonoma. The City of Santa Rosa (City), County of Sonoma (County), and the City of Petaluma (Petaluma) are the three (3) local agencies participating in the program and providing the local funds. This item seeks Council approval of a Funding Agreement and Grant Agreement for \$1.3 million in local funds for the two-year pilot program, which will be matched with \$2.6 million from All Home, for a program total of \$3.9 million. The Committee on the Shelterless (COTS) was selected to serve as the Lead Provider of KPH – Sonoma following a competitive Request for Proposals (RFP) released by the City on May 29, 2024. The \$1.3 million in local funds will be awarded to COTS per the Grant Agreement. All Home will enter into a separate agreement with COTS for the administration of its \$2.6 million. This item also seeks Council's endorsement of All Home's Regional Action Plan 2024.

BACKGROUND

- Bay Area non-profit organization, All Home's Regional Action Plan 2024 (Attachment
 1) recommends concurrent investments in three interventions to effectively reduce
 unsheltered homelessness interim housing, permanent housing, and
 homelessness prevention.
- 2. Data provided by All Home shows that across the nine-county Bay Area region, three people are becoming homeless for every one that is housed by local homeless response systems. In Sonoma County, 35% of people surveyed as part of the 2023 homeless Point-in-Time Count reported 2023 as their first episode of homelessness, indicating a need for prevention services. This need is also identified in the City's Homelessness Solutions Strategic Plan (2023 2027) and the Sonoma County Homeless Coalition's (our local Continuum of Care) 5 Year Strategic Plan to Prevent and End Homelessness and the Petaluma's Strategic Action Plan to End Homelessness.
- 3. All Home has worked with several Bay Area communities to develop and test a regionally coordinated homelessness prevention system for households at or below 50% of Area Median Income (AMI). The system pairs rapid, flexible financial assistance with housing stabilization services and legal aid referrals for people facing eviction. Households are prioritized using an on-line technology platform, including an evidence-based assessment tool, developed and maintained by All Home and Bay Area Community Services (BACS). In addition to Sonoma County, All Home is currently working with Solano County to launch Keep People Housed (KPH) Solano.
- 4. All Home has offered to expand its homelessness prevention model into Sonoma County with technical assistance and a match for local funds to support a pilot program, KPH Sonoma. The City, in partnership with the County and Petaluma, have been working with All Home to develop the program.
- 5. Proposed funding for the two-year pilot program is outlined below.

\$500,000 - City (Homeless Fund Reserves included in FY 2024/2025 budget)

\$500,000 - County (Housing and Homelessness Incentive Program (HHIP))

\$300,000 - Petaluma (General Fund)

\$2,600,000 - All Home match*

\$3,900,000 Total

*Includes initial commitment of \$1.3 million prior to release of RFP, plus additional \$1.3 million for a total of \$2.6 million

6. On May 29, 2024, the City released an RFP with a due date of June 20, 2024 in the amount of \$2.6 million seeking proposals from qualified agencies to operate KPH – Sonoma. Per the RFP, proposers were directed to apply as a collaborative,

comprised of a Lead Provider with partner agencies or "Local Hubs" (one per subregion) to assist with the delivery and administration of KPH – Sonoma. The subregions include Central County/Santa Rosa, West County, North County, South County, and Sonoma Valley.

7. A total of four (4) proposals were received from the following agencies: BACS, COTS, Catholic Charities of the Diocese of Santa Rosa (CCDSR), and Sonoma Community Action Network (CAN), formerly Community Action Partnership of Sonoma County. The proposals are discussed in more detail in the Analysis section.

PRIOR CITY COUNCIL REVIEW

On November 15, 2022, Council approved the Homelessness Solutions Strategic Plan (2023 – 2027) and authorized the City Manager to make minor or non-substantive modifications to amend the plan to ensure alignment with the Sonoma County Homeless Coalition's regional plan. The Strategic Plan, specifically Strategy One (Improve System Performance), identifies a need for homelessness prevention services and is also part of the Year Two Implementation Plan, developed to operationalize the three key strategies outlined in the Strategic Plan.

ANALYSIS

- 1. On July 2, 2024, an evaluation committee reviewed and scored the proposals. The committee was comprised of representatives from the City's Housing and Community Services Department, County Department of Health Services, and Petaluma.
- 2. A summary of the proposals received is provided below.

3. The proposal submitted by COTS received the highest average score, as shown below. The full criteria utilized to determine scores can be found in Attachment 2. Based on the scoring, the evaluation committee recommends COTS to be the operator of KPH – Sonoma.

- 4. Following conclusion of the RFP process and review and scoring of the proposals by the evaluation committee, All Home made an additional commitment of funds (\$1.3 million). Staff estimates approximately 350 to 400 households will be served over the two-year program with the increased funding.
- 5. The City will be serving as the administrator of the local funds and overseeing COTS' operation of the program. In order to facilitate this arrangement, staff is requesting approval of the following agreements:
 - Funding Agreement with the County and Petaluma which confirms the commitment of local funds (\$1.3 million).
 - Grant Agreement with COTS in the amount of \$1.3 million to operate KPH –
 Sonoma for the period October 1, 2024 to June 30, 2026. Per the Grant
 Agreement's scope of services, COTS as Lead Provider, will be the sole
 administrator of financial assistance payments provided to landlords; oversee
 subcontracted services provided via Local Hubs; and submit all reports to the
 City on services provided. COTS will also serve as the Local Hub for the
 South County subregion.
- 6. All Home will enter into a separate grant agreement with COTS for administration of its \$2.6 million contribution, the majority of which will be prioritized for direct financial assistance with approximately \$400,000 allocated for legal services to be subcontracted to Legal Aid of Sonoma County.
- 7. Staff is also seeking Council's endorsement of All Home's Regional Action Plan 2024, which recognizes All Home's technical and financial support for KPH Sonoma and confirms the City's commitment to partner with its Bay Area partners to implement regional solutions to address homelessness.
