RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING THE ISSUANCE OF A PURCHASE ORDER FOR THE COOPERATIVE PURCHASE OF LTE CELLULAR CAPABLE RADIOS AND ASSOCIATED SOFTWARE UNDER THE HOUSTON-GALVESTON AREA COUNCIL (H-GAC) SOLICITATION RA05-21 WITH MOTOROLA SOLUTIONS, INC.

WHEREAS, the Police Department requires replacement of the portable radios to provide clear, reliable radio communications at all time for the safety of the community and staff; and

WHEREAS, following a competitive solicitation No.RA05-21 issued under the Houston-Galveston Area Council's (H-GAC) Cooperative Purchasing Program, H-GAC and Motorola Solutions, Inc. (Motorola) entered into a Master Agreement, which allows other local government agencies to purchase radio equipment at the prices negotiated under the agreement; and

WHEREAS, Section 3-08.160 of the Santa Rosa City Code allows for purchase of supplies, material, equipment, and services made under a cooperative purchasing program maintained by other public agencies; and

WHEREAS, the Police and Finance Departments would like to utilize the cooperative arrangement administered by H-GAC to purchase 45 LTE cellular capable radios and software from Motorola; and

WHEREAS, the Police and Finance Department staff requests and recommends Council approve the issuance of a Purchase Order to Motorola Solutions, Inc. to purchase 45 LTE cellular capable radios and software as set forth in Motorola Solutions, Inc. Quote-2667108 attached hereto as Exhibit A in an amount not to exceed \$333,325.19.
