

**EIGHTH AMENDMENT
TO GENERAL SERVICES AGREEMENT NUMBER F001852
WITH SMILE BUSINESS PRODUCTS, INC.**

This Eighth Amendment to Agreement number F001852, dated January 15, 2019 ("Agreement") is made as of this _____ day of _____, 2025, by and between the City of Santa Rosa, a municipal corporation ("City"), and Smile Business Products, Inc., a California Corporation ("Contractor").

RECITALS

- A. City and Contractor entered into the Agreement for Contractor to provide copier lease, maintenance, and repair services. The First Amendment replaced Exhibit B with Exhibit B-1 and increased compensation. The Second Amendment added a copier to the City's copier fleet and replaced Exhibit B-1 with Exhibit B-2. The Third Amendment added a copier to the City's copier fleet and replaced Exhibit B-2 with Exhibit B-3. The Fourth Amendment added a copier to the City's copier fleet and replaced Exhibit B-3 with Exhibit B-4 and increased compensation. The Fifth Amendment added a copier to the City's copier fleet and replaced Exhibit B-4 with Exhibit B-5. The Sixth Amendment extended the term for one year and returned two copiers with no increase in price or compensation. The Seventh Amendment exchanged a b/w copier for a color copier and replaced Exhibit B-5 with Exhibit B-6 with no increase in compensation.
- B. City and Contractor now desire to amend the Agreement for the purpose of a) returning a b/w copier, C1768 from the City's copier fleet and exchanging it with color copier MX-5070V series with no increase in compensation and b) extending the term for one year with an increase in compensation in the amount of \$200,000 with a 10% decrease in contract pricing.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. **TERM, SUSPENSION, TERMINATION**
Pursuant to Section 6(a) of the Agreement, the parties hereby agree to extend the term of the Agreement for an additional year.
2. **COMPENSATION**

Exhibit B-6 is replaced by Exhibit B-7 attached to this Amendment. Section 4 to the Agreement is amended to increase the compensation payable to Contractor under the Agreement by \$200,000 to read as follows:

The total of all fees paid to Contractor for the satisfactory performance and completion of all services shall not exceed the total sum of \$1,433,173.80. The Chief Financial Officer is authorized to pay all proper claims from various department charge numbers."

All other terms of the Agreement shall remain in full force and effect.
