

RESOLUTION NO. RES-2024-013

RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA RATIFYING THE THIRD AMENDMENT TO SERVICE AGREEMENT NUMBER F001539; APPROVING THE FOURTH AMENDMENT TO SERVICE AGREEMENT NUMBER F001539 FOR GOVERNMENTJOBS.COM, INC. (DBA “NEOGOV”); AND AUTHORIZING THE HUMAN RESOURCES DIRECTOR TO EXECUTE THE FOURTH AMENDMENT TO SERVICES AGREEMENT NUMBER F001539

WHEREAS, on August 27, 2017 the City entered into an agreement with GovernmentJobs.com, Inc. (dba “NEOGOV”) (“Agreement”) to provide ongoing online applicant management, applicant testing, employee onboarding, evaluation, and training and development; and

WHEREAS, the City executed a First and Second Amendment to the Agreement under the authority of the City Manager for increase in compensation and time of performance; and

WHEREAS, on January 28, 2020, by Resolution RES-2020-007, Council approved the Third Amendment to the Agreement in the amount of \$163,302.20; and

WHEREAS, staff wishes to ratify the Third Amendment to the Agreement which was inadvertently executed by the Human Resources Director but that authority was not granted by the Council under Resolution RES-2020-007; and

WHEREAS, simultaneously the City desires to approve the Fourth Amendment to the Agreement to add Position Import integration and extend the time of performance to December 30, 2026 and increase the compensation payable under the Agreement to an amount not to exceed \$949,068.33.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Santa Rosa ratifies the Third Amendment to Service Agreement Number F001539, previously approved by Council to authorize the signing of the Third Amendment by the Human Resources Director.

BE IT FURTHER RESOLVED that Council approves the Fourth Amendment to Service Agreement Number F001539 with GovernmentJobs.com, Inc. (dba “NEOGOV”) in the amount of \$714,102.06 for a total contract amount of \$949,068.33.
