

RESOLUTION NO. RES-2025-024

RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA ACKNOWLEDGING RECEIPT OF THE SB1205 STATE MANDATED REPORTING FOR YEARS 2022, 2023 AND 2024

WHEREAS, California Health & Safety Code (HSC) Section 13146.4 was added in 2018, and became effective September 27, 2018; and

WHEREAS, HSC Sections 13146.2 and 13146.3 requires all fire departments, including the Santa Rosa Fire Department, that provide fire protection services to perform annual inspections in every building used as a public or private school, hotel, motel, lodging, house, apartment house, and certain residential care facilities for compliance with building standards, as provided; and

WHEREAS, HSC Section 13146.4 requires all fire departments, including the Santa Rosa Fire Department, that provide fire protection services to report annually to its administering authority on its compliance with HSC Sections 13146.2 and 13146.3; and

WHEREAS, the Council of the City of Santa Rosa intends this Resolution to fulfill the requirements of the HSC regarding acknowledgement of the Santa Rosa Fire Department's compliance with HSC Sections 13146.2 and 13146.3.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of Santa Rosa that the Council acknowledges receipt of the report of the Santa Rosa Fire Department's compliance with California Health & Safety Code Sections 13146.2 and 13146.3 for calendar year 2023/2024 in the area encompassed by the City of Santa Rosa, as follows:

A. EDUCATIONAL GROUP E OCCUPANCIES:

Educational Group E occupancies are generally those public and private schools used by more than six persons at any one time for educational purposes through the 12th grade.

During calendar years 2022, 2023 and 2024, within the City of Santa Rosa, there were a total of 57 known Group E Occupancies, buildings, structures and/or facilities. In 2022 the Fire Department completed the annual inspection of 40 facilities. This is a compliance rate of 70% for this reporting period. In 2023 the Fire Department completed the annual inspection of 44 facilities. This is a compliance rate of 77% for this reporting period. In 2024 the Fire Department completed the annual inspection of 31 facilities. This is a compliance rate of 54% for this reporting period.

B. RESIDENTIAL GROUP R OCCUPANCIES:

Residential Group R occupancies, for the purpose of this resolution, are generally those occupancies containing sleeping units and including hotels, motels, apartments (three units or more), etc. as well as other residential occupancies (including several residential care facilities). These residential care facilities have a number of different sub-classifications, and they may contain residents or clients that have a range of needs including those related to custodial care, mobility impairments, cognitive disabilities, etc. The residents may also be non-ambulatory or bedridden.

During calendar years 2022, 2023 and 2024, within the City of Santa Rosa, there were a total of 860 known Group R Occupancies, buildings, structures and/or facilities. In 2022 the Fire Department completed the annual inspection of 645 Group R facilities. This is a compliance rate of 75% for this reporting period. In 2023 the Fire Department completed the annual inspection of 573 Group R facilities. This is a compliance rate of 67% for this reporting period. In 2024 the Fire Department completed the annual inspection of 416 Group R facilities. This is a compliance rate of 48% for this reporting period.
