This First Amendment to Agreement for Adjustments to City Owned Utility Facilities		
("Amendment"), dated as of7/08/2025	("Effective Date"), is made by and	
between the City of Santa Rosa, a municipal corporation ("CITY"), and the County of Sonoma		
a political subdivision of the State of California ("COUNTY").		

#### RECITALS

WHEREAS, CITY and COUNTY entered into that certain Agreement for Adjustments to City Owned Utility Facilities ("Agreement"), dated February 6, 2018; and

WHEREAS, CITY and COUNTY desire to amend the Agreement to increase the contract value and update contact information.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

#### AGREEMENT

- 1. Section 6.1 of the Agreement is hereby deleted in its entirety and replaced with the following language:
  - "6.1 This Agreement is valid for a cumulative not-to-exceed total amount of \$1,000,000."
- 2. Section 7.8 is hereby deleted in its entirety and replaced with the following language:
  - "7.8 Method and Place of Giving Notice, Submitting Bills, and Making Payments.

All notices, bills, and payments shall be made in writing and shall be given by personal delivery or by U.S. Mail or courier service. Notices, bills, and payments shall be addressed as follows:

When a notice, bill, or payment is given by a generally recognized overnight courier service, the notice, bill, or payment shall be deemed received on the next business day. When a copy of a notice, bill, or payment is sent by electronic means, the notice, bill, or payment shall be deemed received upon transmission as long as (1) the original copy of the notice, bill, or payment is deposited in the U.S. mail and postmarked on the date of the electronic transmission (for a payment, on or before the due date), (2) the sender has a confirmation of the electronic transmission, and (3) the electronic transmission is transmitted before 5 p.m. (recipient's time). In all other instances, notices, bills, and payments shall be effective upon receipt by the recipient. Changes may be made in the names and addresses of the person to whom notices are to be given by giving notice pursuant to this Section."
