








# Background

- Cells 1-8
  - Constructed in 1989
  - R&R in 2016 (C01829)
- Cells 9-14
  - Constructed in 1994
  - Replacement (this project)

- (24x) 24" Filter Valves, Valve Actuators & Extensions
- (6x) 8" Filter Valves, Valve Actuators & Extensions
- Construction 2025

- Invitation for Bids Solicited on Planet Bids January 19, 2024
- Subject to Community Workforce Project Labor Agreement (PLA) requirements
- 13 Contractors Registered to Bid on Project
- Bids Received & Opened March 13, 2024
- Total of 4 Bids Received, 1 Contractor Considered Local

### Analysis

- Low Bidder TNT Industrial Contractors, Inc. of Sacramento, CA
- Low Bid was 64.4% over Engineer's Estimate
- DIR Registered, Licensed



### Analysis

Potential Factors for Disparity Between Engineer's Estimate & Lowest Bid:

- Estimate Not Updated Prior to Posting
  - Original Estimate (12/2022) \$1.63M
  - 12 month Escalated Estimate (12/2023) \$1.74M
  - 24 month Escalated Estimate (12/2024) \$1.86M
- Materials Have Long Lead Time ~1 yr
- Community Workforce Project Labor Agreement Impacts



#### Recommendation

It is recommended by the Departments of Water and Transportation and Public Works that the Board of Public Utilities, by motion, award Contract No. C02096, Laguna Treatment Plant Filter Cells 9-14 Valve and Actuator Replacement, in the amount of \$2,674,200 to the lowest responsible bidder, TNT Industrial Contractors, Inc. of Sacramento, CA, approve a 12% contract contingency, and authorize a total contract amount of \$2,995,104.
