 ELECTRICAL UPGRADES, CONTRACT NO. C02438

RECOMMENDATION: It is recommended by Santa Rosa Water and the Transportation and Public Works Department that the Board of Public Utilities, by motion, award Construction Contract No. C02438 in the amount of \$2,144,600.00 to the lowest responsive bidder, CWS Construction Group, Inc. of Novato, CA, for Water Pump Station 9 Electrical Upgrades, approve the project, approve a 15% contingency, and authorize a total contract amount of \$2,466,290.00.

14. DIRECTORS REPORTS

Director Burke reported and answered Board Member questions: As part of our ongoing fiduciary responsibility in relation to the operations of our systems, and with direction from the City Manager to look for ways to improve or reduce cost, an opportunity has been identified and beginning January 6, 2025, customers will begin paying to process credit card payments. There will still be fee free election option to pay which will be a direct debit from a bank account. This fee will allow Santa Rosa Water to recover the credit card processing fees that we are currently charged for and pay for on behalf of our customers. This will allow us to recover between \$600,000 to \$700,000 annually. The transaction fee will be a 2.59% fee, with a minimum of \$1.95. There is a communications plan in place including information and instructions on our website, in our bill inserts, through e-bill messages, and postcard mailers to all customers.

Thank you to the Board for their support in adopting a resolution for Deputy Director Peter Martin's application for the ACWA Region I Board. Deputy Director Martin was elected to the Region I board for the 2026/2027 term.

Assistant City Manager Jason Nutt expressed his gratitude to Santa Rosa Water for the presentations and tour given to the Army Corps of Engineers representatives and to Congressman Huffman and his team.

Last week we had out a contingent from the Army Corps of Engineers, as well as Congressman Huffman and his staff, to the Llano Trunk Lining Phase I project. This project has a Water Resources Development Act authorization from Congressman Thompson, and Congressman Huffman has put forth bills to get us an appropriation for fiscal year 2026. The appropriation Congressman Huffman has put forward is for almost \$2.3 dollars.
