I am the organizer of a film discussion meetup group (membership currently 564 persons, largely seniors). Between 5 and 12 of us meet weekly at the Summerfield Cinema to view a film and then meet in a nearby restaurant to eat and discuss the film. There are two reasons why the above noted "Minor Conditional Use Permit" modification should not be granted at your June 6 meeting:

- 1) The Summerfield Cinema is the only Santa Rosa film theater which shows independent, and foreign made films (the only types our group views). The loss of this Cinema by the building's conversion to a different use would create significant harm to an active community of Santa Rosa citizens, many of whom being seniors cannot easily drive to another town to view films. The "Human Impact" alone may well represent the kind of significant Environmental Impact requiring further study, and a formal report before zoning change occurs.
- 2) I believe that the characterization of this matter as a "Minor Conditional Use Permit and Minor Design Review "requiring only "minor exterior modification to the front of the existing commercial building" (and thus exempt from CEQA) is an error and a mischaracterization of the physical facts of the property structure, and the proposed modification. This building is currently used as a cineplex of five separate sloping theater auditoriums each built on what I believe is a concrete pad. It is hard to imagine how exercise equipment could be placed on this sloping flooring without complete demolition and removal of the existing flooring. I am no engineer, but I wonder if City Engineers have been consulted regarding whether such change to the building pad might require shoring up the older stone walls of the existing structure? In the end, perhaps such building modification might be financially unfeasible, and require demolition of the existing structure? This would involve extensive impact on nearby existing businesses, and nearby residential housing.

In summary, I believe your June 6 Zoning meeting is far too early for a final decision on a matter which should require further study and consideration of all it's many impacts on the community.

We typically host one to two movies a week and have been doing this for over 10 years. Over 90% of the movies scheduled are at the Summerfield Cinema (previously Rialto) since it specializes in non-mainstream films that are the focus of our group.

The Summerfield Cinema provides our group and the Santa Rosa area with a movie venue that explores unconventional or niche topics that are largely ignored by the main-stream movie houses. I believe this is an important cultural benefit to the city and adds more to the desirability of living here than adding another gym.

As an aside, since we typically discuss the movie afterwards over a meal, as I am sure other movie goers do as well, the East West Restaurant would likely be negatively impacted by the loss of the Cinema next door.

I am a huge fan of Star Wars and Star Trek and other big adventure films, which I can find at the other Santa Rosa Cinemas locations. But I also enjoy the smaller films, the independent and foreign films that are shown only at the Summerfield. The "disappearance" of this Cinema would be huge loss!

Second, one of the comments talked about small, local, independent business in and around the area. I must say that I agree with the points expressed in that letter. Having a national chain business move into this area will bring changes that will likely hurt many of the local businesses. There is a kind of chain reaction — in comes the first national chain, which then becomes the support for the next one, and then the next — and so on. There are plenty of areas in Santa Rosa where it would be more appropriate to have the big-box type of businesses, and a better fit for Planet Fitness.

Third, the traffic-impact report, Attachment 3, discusses the number of trips, with the emphasis on impact to peak hours. That is, of course, important . Equally, if not more important to me, as a nearby resident, is the traffic resulting from the extended operational hours of the business. I am not keen on having an increase of "crack-of-dawn" and late-night, even all-night traffic. It is the noise and possible threats to public safety that concern me. I own a small sewing business located at 4000 Montgomery Dr. very near the site. Im requesting that this letter please be included in the public record.

In trying to keep this letter brief, I will quickly outline the major reasons so many of us oppose the permitting of the Planet Fitness Gym at this location:

\*Small businesses are healthy for the community, while large corporate chains and franchises generally are not:

-Profits made by corporate businesses do not stay in the local community. The developer for this project

is based in southern California and isn't even local.

- -Corporate and large chain franchises drive out small businesses with competitive tactics and rental increases. We've seen this over and over. Strip mall tactics don't provide real community spaces or sustainable small business districts.
- -Corporatizing what is currently a very productive small business district will forever alter the neighborhood and what is allowable in its zoning. We believe that because the Lakeside district does

admittedly need some updating in its streetscaping that the city planners as well as the permit applicant

may have mistakenly assumed that it is not a thriving business hub, but it is: the small businesses located in the Lakeside district are currently providing a lot of necessary services to the local neighborhood residents, such as restaurants, hair salons, tailoring services, repair shops, massage therapists, and more, and with formational plans brewing to create an even more diverse walkable retail

district. Establishing a large corporate franchise at such a prominent location in the heart of a small business district will forever alter its appearance, price range, and overall sustainability and charm.

We are asking the planning dept. to please use greater consideration in separating big businesses from

small business in their determination of which projects should be permitted.

\*Big Box Gyms such as Planet Fitness are Not Green!!

-Gyms of this size and nature are notorious for their large carbon footprint due to the high electrical and water usage as well as traffic flow emissions from customers driving to and from the premises. So far as the public has been informed, the developer/applicant has presented no plans to include any forward thinking or environmentally friendly aspects in their business plan:

- \*No solar panel or alternative energy plans?
- \*No greywater system plans?
- \*No landscaping or arborial plans?

-Howarth Park already provides a multitude of environmentally friendly fitness opportunities such as hiking, walking, rowing, tennis and pickleball courts, fitness bars, as well as baseball and soccer fields, with the Parks dept. planning on further expansions soon. Adding a Planet Fitness Gym directly

across the street is not only undesirable on an idealogical and economic level, it is a superfluous addition to a city block that is already laden with fitness opportunities, with an additional likelihood of

causing traffic and parking complications.

\*Theres already 20 big box gyms in Santa Rosa, several of which are 24 hour access, as well as many independently owned alternative fitness centers such as yoga studios, dance studios, smaller gyms, etc. some of which are already located in or near the lakeside district. These smaller independent fitness businesses may be harmed by introduction of a corporate gym such as Planet Fitness. Let these small businesses stay in business and continue to acquire new clientele that might be funneled away from them by the bait and switch membership tactics of large chain gyms.

<sup>\*</sup>There are already established, green, sustainable fitness opportunities directly across the street from the proposed permit site at our beloved Howarth Park.

We would be happy to discuss any and all of these points as well as supportive data and signed petitions and pledges from local citizens and small business owners if and when there is time or opportunity.

Derek Stefan and Paul Seif are circulating the 'Save the Summerfield Theater' petition which has over 1200 signatures at last count.

I am representing 7 other small business owners in the Lakeside district in this communication (for which I can provide signatures an email contacts if requested) and am still circulating an expanding petition among the other owners as time allows.

We are planning to attend the next planners meeting this Thursday the 18th with as many other concerned neighbors as possible to show how important we feel this decision is.

The argument has been made by a few that because the entire property where the site in question is located (and not just the building itself) is for sale, that only a high finance investor or corporate developer will be the one to ultimately acquire the property and that this is a certain eventuality for market rate reasons. We find this to be a short sighted and disconnected viewpoint and hope that the planning dept. does not rely purely on this type of corporate profit rhetoric as part of its determination on the permit. There are any number of creative and lucrative ways to use the entire property for small sustainable businesses that will benefit the community and maintain the district, and we rely on our city planners and our district representatives to protect and invest in the best interests of the local citizens and to not be lured into the interests of wealthy developers at the cost of our communities.

My name is Derek Stefan, Santa Rosa born and raised, long time resident of the JC Neighborhood. As a member of the recently formed Citizen Committee to save Summerfield Cinemas, I urge the Zoning Administrator and City Planning to further delay on granting the use permit to Planet Fitness and Centers Dynamic Partners.

This shopping center known as Lakeside was built in the 1950s - 1960s has a mid century architecture and low roof line that is not conducive to a large big-box format building. The significance of these business districts at Lakeside and the neighboring shopping center on Montgomery Drive known as "The Village" were built around the same time; they hold many long-established small and local businesses. These enterprises need to be protected and nurtured, not destroyed.

I urge Mr. Arce and Centers Dynamic Partners, as out of town investors and developers, to lean in to the fact that a large majority of citizens do not want you to develop this property with a Planet Fitness. We

have over 1,300 signers of our petition on Change.org with 60% being from the local North Bay community supporting the effort to Save the Summerfield Cinemas from Demolition.

Perhaps a new vision can be developed using mixed use, high performing revenue generating business models to redevelop this shopping center? Case in point - Sony Pictures Entertainment investing and acquiring cinemas in California and beyond.
