## **RECOMMENDATION**

It is recommended by the Santa Rosa Police Department that the Council, by resolution: 1) approve the First Amendment to Professional Services Agreement Number F002611 with Spectrum Canine Isabel LLC, Morgan Hill, California, increasing compensation by \$94,000 and extending time of performance for an additional three-year term to provide training services for the Police K-9 program; and 2) authorize the City Manager or designee to sign all related contractual documents.

## **EXECUTIVE SUMMARY**

This agreement provides for services from Spectrum Canine Isabel LLC to complete the training required for the Police K-9 program. A minimum of 20 hours per month of training is recommended by the California Police Officer Standards to maintain a street ready and reliable police K-9. This training shall be broken into weekly five-hour training sessions for optimal results with the K9 and handler team.

#### BACKGROUND

The Santa Rosa Police Department entered into a contract with Spectrum Canine Isabel LLC (Spectrum Canine) on April 18, 2023, and have been utilizing their services since that time. The purpose of conducting weekly maintenance training is to provide consistent and constant improvement in the dog and handlers skills. The weekly nature of the training allows the trainers to be in constant management of the dog and K-9 handlers' and address issues that may arise and address them as efficiently as possible to ensure the K-9 team is well prepared for deployments. During weekly maintenance training Spectrum Canine provides a mixture and variety of services, as needed for the K-9 team to maintain optimal performance and street readiness.

## <u>ANALYSIS</u>

The primary goal of weekly maintenance training is to ensure continuous improvement in the skills of both the dog and the handler. This regular training schedule allows trainers to consistently monitor and manage the performance of the K-9 team, promptly addressing any issues that arise. This proactive approach ensures that the team is always prepared for deployments.

Spectrum Canine offers a diverse range of services during these weekly sessions, tailored to the specific needs of each dog. This variety helps maintain the optimal performance and street readiness of the police K-9.

## FISCAL IMPACT

The funding for this agreement is included in the approved Fiscal Year 24/25 Police Department budget.

## **ENVIRONMENTAL IMPACT**
