AGENDA ACTION: RESOLUTION

It is recommended by the Fire and Finance Departments that the Council, by two separate resolutions, approve two General Service Agreements for grazing services: 1) General Services Agreement No. F002943 to Capra Environmental Services, Corp, Roseville, California in the amount of \$125,000; and 2) General Services Agreement No. F002944 to Therese Oyarzun dba Goats R Us, Orinda, California, in the amount of \$125,000, for a total not to exceed \$250,000 for both contracts.

EXECUTIVE SUMMARY

The Fire Department submitted Purchase Requisition R167038 requesting Purchasing to bid and award two vendors with a two-year contract with three one-year options to extend for grazing services for various locations in the City. Grazing is a component of the wildfire risk reduction strategy employed by the Santa Rosa Fire Department (SRFD). Grazing livestock will be deployed into the various city owned open space and undeveloped areas within the city and will graze hazardous vegetation to reduce the threat of wildfire at that location.

BACKGROUND

Based on recommendations from the Community Wildfire Protection Plan (CWPP), which the City Council accepted and approved on August 25, 2020, targeted grazing activities were identified as a critical method of reducing the fuel load in areas throughout the City. One of the key objectives outlined in the CWPP was to assist public and private entities with taking meaningful actions to reduce wildfire intensity and provide greater community protection. The actionable items to support this objective included securing a contract for grazing that can be utilized on City-owned parcels where grazing activities can directly benefit the community.

ANALYSIS

Grazing services can be more efficient than mechanical and hand work in certain geographical locations. Lands can be cleared quickly utilizing livestock and can be functional 24 hours a day. Additionally, grazing allows for easier and safer access to areas difficult for mechanical or hand crew removal due to slope and rugged terrain.

This item aligns with the City Council Mission, Vision, Values, Goals and Priorities by maintaining sustainable infrastructure, achieving organizational excellence, and addressing climate change through taking this holistic approach through the safety of the community.

On October 22, 2024, Invitation for Bids (IFB) 24-44, solicited by the City of Santa Rosa for grazing services, was opened. Five proposals were received, one offer was deemed nonresponsive, and four offers were considered responsive to the solicitation. A tabulation of the responsive and responsible bids received is listed below:

The Agreement with Capra Environmental Services Corp will be the primary contract with Therese Oyarzun dba Goats R Us as the backup contract if needed.

FISCAL IMPACT

Funding for the entirety of the two grazing contracts will come out of the PG&E Vegetation Management Project account (P05109). This is a one-time expenditure for both two-year contracts with three one-year options to extend services. There is no anticipated maintenance cost associated with these contracts.

ENVIRONMENTAL IMPACT

Pursuant to CEQA Guidelines Section 15378, the proposed action is not a "project" subject to the California Environmental Quality Act (CEQA) because it does not have a potential for resulting in either a direct physical change in the environment or a reasonably foreseeable indirect physical change in the environment. In the alternative, the proposed action is exempt from CEQA pursuant to CEQA Guidelines Section 15061(b)(3) because it can be seen with certainty that there is no possibility that the project may have a significant effect on the environment.
