Dear Mayor Rogers, Vice Mayor Stapp, and City Council of Santa Rosa,

With regret, I am unable to attend your meeting this morning. It was only brought to my attention yesterday, so please forgive my delinquency in the timing of this correspondence. However, I do hope that you will consider the following as you strategize and set goals for the City of Santa Rosa.

The Sonoma County Farm Bureau is a non-profit, membership organization whose mission is to represent, protect, and advance the social, economic, and educational interests of the farmers and ranchers of Sonoma County. Our 1,800 members encompass thousands of acres in rural Sonoma County which lends itself to the beauty and sense of place and welcome for all who live, work, and visit here. While most of our members are not residents of the City of Santa Rosa, there are synergies between us that should not go unnoticed. Our members rely on businesses within the city limits for goods and services that keep their businesses and properties thriving. The residents of the City of Santa Rosa, along with all of the County of Sonoma, rely on the local food, fiber, and goods produced by the farmers and ranchers in the county, in addition to open spaces, and the benefit of our scenic corridors so passionately cared for by the farmers and ranchers made up mostly of multi-generational families.

Like so many, there is no shortage of challenges among our members. As businesses, we toil with economic challenges just like any other; however, we are price takers so we must strategize a little differently. We are faced with labor challenges which may look a little different in the non-ag sector, but a challenge, nonetheless. Regulations continue to burden our bottom line, compatible with other business sectors.

These are only a few, but I want to bring to your attention a very large threat to our local food system, economy, and landscape. Animal activists have been trying for years to infiltrate and essentially end the poultry industry in Sonoma County. They continue to trespass on facilities to coordinate their message based on what they want people to think, versus the facts and realities of livestock husbandry. Their efforts have resulted in arrests and even convictions, but this has not stopped or even slowed their efforts. Their most recent attempt at pushing their agenda is working to put an initiative on the November ballot that seeks to eliminate "Concentrated Feeding Operations" in Sonoma County. In short, this is a direct attack on Sonoma County poultry and egg farms and dairies. Should this make it on the ballot and pass, it will essentially debilitate local poultry, egg and milk production, requiring these products to be brought in from outside of Sonoma County.

Our poultry and egg farms and dairies follow animal welfare programs where they are inspected by third-party auditors to ensure the compliance of proper animal husbandry as set forth by the program they follow. Each program is devised by advisory committees made up of animal scientists, veterinarians, retailers, and consumers. Our farmers, ranchers, and dairy producers have and will always put the comfort, health, and well-being of their animals first. Also, most of our local operations are organic and make up a significant portion of organic production in the entire state. The current level of production and market accessibility allows consumers to choose what they buy.

Animal activists do not fundamentally believe in animal agriculture so no matter what we do, they will continue to attack and spread misinformation to get others to conform to their way of life and thinking. If their overall mission to eliminate all animal agriculture in the nation within the next two generations is successful, their approach would take away a person's right to choose what they put on their plate or pour into their glass.

On behalf of the Sonoma County Farm Bureau, and its 1800 members, I ask that an important goal is to include continuous discussions and working relationships with our organization and our members to truly understand not only our synergies but our importance on the local economy, food production, natural resources, and Sonoma County's way of life.
