



## CITY OF SANTA ROSA NOTICE OF PUBLIC HEARING

THE CITY COUNCIL WILL CONSIDER RETITLING AND AMENDING SANTA ROSA MUNICIPAL CODE CHAPTER 2-04, BOARD OF COMMUNITY SERVICES, TO CHANGE THE NAME OF THE ADVISORY BODY FROM BOARD OF COMMUNITY SERVICES TO RECREATION AND PARKS BOARD, UPDATE THE BOARD'S POWERS AND DUTIES TO REFLECT THEIR CURRENT ROLE, ALIGN THE NUMBER OF MEMBERS WITH THE NUMBER OF CITY COUNCIL MEMBERS, REDUCE THE NUMBER OF MEMBERS NEEDED TO ACHIEVE QUORUM, ALIGN MEMBER'S TERMS TO COINCIDE WITH THE TERM OF THEIR APPOINTING COUNCIL MEMBER, AND UPDATE THE PROCESS FOR MEMBER APPOINTMENT TO AND MEMBER REMOVAL FROM THE BOARD TO ACCURATELY REFLECT THE CITY CHARTER AND COUNCIL POLICY 000-06. THE COUNCIL WILL ALSO CONSIDER AN ASSOCIATED AMENDMENT TO COUNCIL POLICY 000-06 TO CHANGE THE NAME OF THE ADVISORY BODY TO RECREATION AND PARKS BOARD.

Notice is hereby given that a public hearing will be conducted by the City Council on Tuesday, April 1, 2025, at or after 5:00 p.m. The purpose of the public hearing will be to receive public comment and recommendations prior to the City Council acting on an ordinance to retitle and amend Santa Rosa Municipal Code Chapter 2-04, Board of Community Services.
