SECOND AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT NUMBER F002053 WITH MARK A CLEMENTI, PH.D.

This Second Amendment to Agreement number F002053, dated October 21, 2019 ("Agreement") is made as of this _____ day of _____, 2024, by and between the City of Santa Rosa, a municipal corporation ("City"), and Mark A. Clementi, Ph.D., a sole proprietor ("Consultant").

RECITALS

- A. City and Consultant entered into the Agreement for Consultant to provide preemployment psychological evaluations, return to duty/fitness for duty psychological evaluations and critical incident stress debreifings.
- B. City and Consultant now desire to amend the Agreement for the purpose of extending the term of the contract and adding funding.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. Section 1. Scope of Services

Exhibit A to the Agreement is supplemented by Exhibit A-1 to this Amendment.

2. Section 2. Compensation

Section 2(c) is amended to increase the compensation payable to Consultant under the Agreement by \$75,000.00 to read as follows:

"Notwithstanding any other provision in this Agreement to the contrary, the total maximum compensation to be paid for the satisfactory accomplishment and completion of all tasks set forth above shall in no event exceed the sum of One hundred, seventy thousand and no cents (\$170,000.00). The City's Chief Financial Officer is authorized to pay all proper claims from various Charge Numbers."

3. Section 12. Time of Performance

The last sentence of Section 12 is amended to read as follows:

"Consultant shall complete all the required services and tasks and complete and tender all deliverables to the reasonable satisfaction of City, not later than September 1, 2027."

All other terms of the Agreement shall remain in full force and effect.
