RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING AN AGREEMENT FOR SCHOOL RESOURCE OFFICERS BETWEEN THE CITY OF SANTA ROSA AND SANTA ROSA CITY SCHOOLS DISTRICT TO RELAUNCH THE SCHOOL RESOURCE OFFICE PROGRAM; DELEGATING AUTHORITY TO THE CITY MANAGER TO EXECUTE THE AGREEMENT; AND AUTHORIZE THE CITY MANAGER TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH SANTA ROSA CITY SCHOOLS FOR EQUITABLE COST-SHARING IN SUPPORT OF THE SCHOOL RESOURCE OFFICER PROGRAM

WHEREAS, the Santa Rosa Police Department recommends that Council approve the Agreement for School Resource Officers Between the City of Santa Rosa Police and Santa Rosa City Schools (SRCS) needed to relaunch the School Resource Officer (SRO) program; and

WHEREAS, this Agreement allows the City of Santa Rosa and the Santa Rosa City Schools to engage in good-faith discussions and negotiations to determine an equitable cost-sharing arrangement for the ongoing operation of the SRO program; and

WHEREAS, it is further recommended that Council authorizes the City Manager to negotiate and execute and agreement with SRCS for equitable cost-sharing in support of the SRO program.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Santa Rosa approves the Agreement for School Resource Officers Between City of Santa Rosa and Santa Rosa City Schools District, in substantially the same form as Exhibit A to the resolution, subject to approval as to form by the City Attorney.
