I am not here for anything I need or myself, but your response is indicative of the world.

A few years ago, I testified before Santa Rosa's City Council regarding Fountaingrove's waterline

contamination reconstruction, which Dr Horenstein implemented and saved over \$35M.

I have 50 years experience in these matters, I'm a 3rd generation CA Civil Engineer.

I am pointing out to you, Local authorities have the power over Caltrans.

95% of "Gas Tax" money must be returned to State of Origin. You have power over that.

No question, Roseland will overcome the prejudice. What sentiments will they have?

We seek easy people to blame, but when that is denied, chaos ensues, in 2020 like Minneapolis, Milwaukee, Portland, Seattle, & Charlottesville!

**Letter to the FDA (Food and Drug Administration) regarding the Citizen's
Petition from Americans for Responsible Technology**

Dear FDA official,

Please wake up and help the dear people of our beautiful USA. We the people are being exposed to the extremely harmful effects of many thousands of telecom small cells and cell towers all over our country as well as the hundreds of devices and products that use this infrastructure.

Most people have no idea that their routers, wireless computers, cell phones, and many smart devices (including smart meters) are harming them. Some of us are aware, and do not use these wireless products but we are still being harmed when there are cell towers and small cells in close proximity to where we live. The invasive and poisoning waves of radiofrequency radiation RFR are spreading throughout our neighborhoods and into our homes.

Hundreds of thousands of people have become very sick with tumors and cancers. They are also experiencing other very debilitating conditions such as insomnia, migraines, exhaustion, dizziness, nausea, heart palpitations, and more. Where are the studies showing no harm? Isn't it the job of the FDA to protect us from these dangerous products and the infrastructure that is ruining our health?

I personally know about these harmful effects because I am one of those people who have become very sick. Over five years ago, when our Santa Rosa City Council and zoning department was approached by the telecom companies to put up their cell towers and small cells, our local government unknowingly took their word that there were no harmful effects. They signed the permits and then whamo! Telecom got their foot in the door and started to take over.

In 2018, a Verizon small cell array was installed on a utility pole just 42 feet from my home. I knew nothing about it until I got a notice telling me that this was going up on said pole. Shortly after the antennas were turned on, I began to experience the debilitating conditions described above. Not even my doctors knew what I had. I was lucky as a dear friend asked me six months later if I thought my conditions were from the small cell next to my house. I thought, "That's it" because I started getting sick right after the antennas were turned on.

I fought it no end. I wrote many letters and made phone calls. I have copies of my correspondence and wrote down the info from all the phone calls. I am still fighting five and a half years later and will continue on until I draw my last breath.

I don't have wifi, don't own a computer or a cell phone and have no "smart" devices except for a smart meter that was forced upon me by Pacific Gas and Electric. The smart meter is now shielded. A year ago, I was given a radiofrequency radiation meter (Safe and Sound Pro 2) from a friend and have taken many hundreds of RFR readings throughout my house and yard. I can only live in several rooms now, and even those are getting to be higher according to my meter. The S&S Pro 2 measures in $\mu\text{W}/\text{m}^2$ (microwatts per meter squared). Building biologists say that anything over 1,000 $\mu\text{W}/\text{m}^2$ is "extreme concern" meaning that people should never be exposed to these high levels long term.

In my house, rooms measure from 5,000 $\mu\text{W}/\text{m}^2$ to 30,000 $\mu\text{W}/\text{m}^2$, and in my yard, RFR ranges from 25,000 $\mu\text{W}/\text{m}^2$ to 195,000 $\mu\text{W}/\text{m}^2$. My life has changed forever... not of my choice. I am homebound. But when I go out, I am so reactive to RFR that I can't be in the vicinity of cell phones or even in certain waiting rooms at doctor's offices. I don't drive, so I ask friends to turn off their phones when they give me rides. I react when passing cell towers while we are on the road. It is very hard to even go shopping or to appointments. I also can't attend my beloved church or go to social activities. The only remedy is avoidance of anything emitting RFR, which I can't even do in my home that I've lived in for 52 years.

I was finally diagnosed in April 2022 with ADA, EHS, electromagnetic hypersensitivity, by a well respected medical doctor. I will have to live with this disabling condition until I die.

What gave our local governments and our federal agencies the right to be the judge and jury, convicting me to a sentence of suffering and taking away my enjoyment of life? They have done this to everyone who's suffering the terrible effects of RFR and continue to do so. When will it stop?

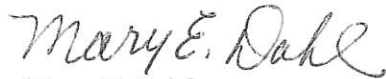
The FDA must take some action and control this takeover. I am told there are thousands of carefully researched studies showing the dangers to humans and other forms of life. We need to protect the people of all ages.

Telecom can no longer use their financial influence over your agency. You must address this matter head on by setting realistic exposure guidelines and issuing

warnings so people know how to protect themselves from small cells, cell towers, and wireless devices. If you are not willing to take action against the powerful telecom industry and issue strong warnings on wireless devices (like you do on cigarettes packages), step aside and let in a group who can do the job completely.

We must stop this horrible invasion before it's too late.
