RESOLUTION OF THE BOARD OF PUBLIC UTILITIES OF THE CITY OF SANTA ROSA ADOPTING NEW AND CHANGED MISCELLANEOUS FEES AND CHARGES

WHEREAS, the Board of Public Utilities has determined that changes are required to the schedule of miscellaneous fees and charges in order that the customer receiving the particular service or causing the incurrence of utility cost or expense will pay the cost thereof and shall be adopted with certain modifications as recommended and justified by staff.
