165140 WITH UNIVERSAL SITE SERVICES, INC.

RECOMMENDATION

It is recommended by the Finance Department that the Council, by resolution, approve the Second Amendment to Purchase Order 165140 with Universal Site Services, Inc., Milpitas, California, for sweeping services at City parking lots, garages, and transit hubs in an amount of \$65,134.32 for a total not to exceed amount of \$262,537.28.

EXECUTIVE SUMMARY

The Transportation and Public Works Department (TPW) and the Parking Division of the Finance Department utilize sweeping services at City parking garages, parking lots, and transit hubs to keep these areas swept and clean from leaves and debris.

BACKGROUND

On May 24, 2021, Invitation for Bid (IFB) 21-31 was opened by the Purchasing Department for sweeping services at City parking lots, garages, and transit hubs. Universal Site Services, Inc. (USS) was determined to be the lowest responsive and responsible bidder.

PRIOR CITY COUNCIL REVIEW

On August 31, 2021, the City Council approved a bid award and issuance of Purchase Order (PO) 165140 for two-years, with an additional three (3) one-year extension options to USS in the amount not to exceed \$132,268.64.

<u>ANALYSIS</u>

PO 165140 expires on August 31, 2024. USS has submitted a one-year extension proposal with no increase in unit cost. See PO History Below:
