MEETING PURPOSE: The purpose of the public hearing will be to receive public comment and recommendations prior to the City Council acting on a request to certify a Final Environmental Impact Report (Final EIR) and approve the Roseland Creek Community Park Master Plan and adopt the related CEQA Findings of Fact and Mitigation Monitoring and Reporting Program.

PROJECT DESCRIPTION: The Roseland Creek Community Park Master Plan project includes paved pedestrian and bicycle trails, community garden or outdoor classroom, nature center and parking, picnic areas with single use barbeques, parking, children’s play areas for ages 2-5 and 5-12, restroom building, sport court, fitness stations, irrigated turf area, two pedestrian bridges, cross walk, looped walking paths, interpretive signage and natural areas.
