### DOWNTOWN ACTION ORGANIZATION 2024 ANNUAL REPORT

During 2024, the sixth year of operation, the Downtown Action Organization (DAO) continued to oversee the budget, manage special projects, maintain assets and administer special services for the Downtown Santa Rosa Community Benefit District.

### Santa Rosa Downtown District Assessments

There was a 5% increase in property assessments in the 2024 Fiscal Year (January 1 through December 31, 2024). The full anticipated amount collected from properties located within the District (page 4) where special benefit services were conducted in 2024 was \$564,504. This reflects payments due on November 1, 2023 and February 1, 2024 and does not include any delinquent payments made after August 1, 2024.

#### **Budget and Expenditures for 2024 Fiscal Year**

An unbudgeted amount of \$98,331 was raised to fund special projects and programming. \$94,596 of which was spent.



## SPECIAL BENEFIT SERVICES FOR 2024 FISCAL YEAR

### PRIMARY DISTRICT SERVICES

Street level services, focused on sanitation, maintenance and safety within the District, are fulfilled through the DAO's contract with NexStreet. Nexstreet employs five dedicated staff members in Downtown Santa Rosa. The chart below reflects a summary of tasks completed during the 6,808 hours worked in 2024.

Data is collected via Jia, NexStreet's technology solution that tracks employees in the field, manages tasks and collects task data to help predict trends in the District.



### **PROJECT MAINTENANCE**

Past infrastructure or improvement projects installed or managed by the DAO require ongoing maintenance and attention throughout the year by experienced contractors. They include:



## SPECIAL BENEFIT SERVICES FOR 2024 FISCAL YEAR

### DISTRICT MANAGEMENT

District management fees includes advocacy and project management, DAO staffing, office space, ongoing management of all legal requirements, financial and administrative services and communication to Downtown community. In 2024, the DAO worked with City staff and elected officials on policies with direct impacts to Downtown community, including launching the Vacant Building & Land program and ongoing work for the SR Now marketing package and website.



In March, a new Downtown website was launched that has seen over 88,000 visits in 2024. The website promotes community events, new businesses and programming taking place in the Downtown. 54% of the audiences that engage with Downtown social channels (Facebook and Instagram) live in Santa Rosa.


### SPECIAL PROJECTS

In 2024, the DAO raised \$67,875 through local funders to pilot the Rose-E Trolley program and test the feasibility of cross town transportation as a means of addressing connectivity issues. The pilot program proved a greater need for regular family friendly activities and programming geared toward tourists. A shortened, more consistent trolley service might be warranted, though it was not recommended to expand the program as it was piloted.

The DAO also worked with the City to install planters and banners on Courthouse Square, bringing color and dimension to the heart of Downtown. The DAO will manage these installations moving forward.
