The purpose of this email is to share the Primary Record (Attachment 5) relevant to the existing on-site structures and the Historic Resource Evaluation (Attachment 6) prepared by the applicant for the Concept Design Review of the 425 Humboldt Apartment Project. In 2023, the City conducted a [Historic Resource Evaluation](#) (HRE) to locate, identify, and document structures and sites within the Downtown Station Area that may be eligible for nomination to the California Register of Historical Resources or the National Register of Historic Places, as well as those of local significance. The HRE aims to facilitate infill housing development by identifying which sites in the Downtown Station Area are historically significant and which do not require further evaluation for historic resources.
