AGENDA ACTION: RESOLUTION

RECOMMENDATION

It is recommended by the Transportation and Public Works Department that the Council, by resolution: 1) request that the Metropolitan Transportation Commission allocate \$251,120 from Fiscal Year 2025/2026 Transportation Development Act Article 3 funds for the installation of various school active transportation improvements that will improve walking and bicycling conditions at select schools that are likely to see an increase in student population due to recent school closures in the Santa Rosa City Schools District; and 2) authorize the Director of Transportation and Public Works to file the application and other required documents to install the improvements, as directed by the Bicycle and Pedestrian Advisory Board.

EXECUTIVE SUMMARY

The City of Santa Rosa (City) gets Transportation Development Act (TDA) Article 3 money allocated annually by the Metropolitan Transportation Commission (MTC). The City is required by MTC to have the City's Bicycle and Pedestrian Advisory Board (BPAB) choose where the money goes by making a recommendation to City Council. The BPAB directed staff to identify safety improvements near schools.

BACKGROUND

The Metropolitan Transportation Commission (MTC), as the regional transportation planning agency for the San Francisco Bay Region, has adopted MTC Resolution Number 4108, which delineates procedures and criteria for submissions of projects for Transportation Development Act (TDA) funds. TDA funds are generated from a statewide 1/4 cent sales tax. Article 3 of the TDA sets aside approximately 2% of those monies for bicycle and pedestrian planning and projects. MTC administers TDA Article 3, which is distributed based on population.

The City annually receives TDA Article 3 funding for bicycle and pedestrian projects. The estimated balance for Fiscal Year (FY) 2025/2026 is \$251,120. The Sonoma County Transportation Authority (SCTA) issued a call for projects in February 2025. TDA 3 project applications were due to the SCTA on March 11, 2025.

MTC requires a local resolution authorizing the request for allocation of FY 2025/2026 TDA Article 3 funds for eligible projects.

PRIOR CITY COUNCIL REVIEW

Not applicable.

ANALYSIS

The City of Santa Rosa has made many upgrades to the City's active transportation network in the past decade to increase safety for those most vulnerable on our roadways. These upgrades help the City meet climate action, Vision Zero, and community resiliency goals adopted by the Council and supported by the public.

Some upgrades, such as those at schools, often occur through examination of existing infrastructure and examination of projects that could enhance bicycle and pedestrian infrastructure and comfort on the active transportation system. Projects include, but are not limited to, installation of Rectangular Rapid Flashing Beacons (RRFBs), High Intensity Activated Crosswalks (HAWKs), new crossing locations, high visibility crossing treatments, curb extensions, road diets, or speed cushions. Such improvements are often identified through various processes, such as school walking audits in partnership with the Safe Routes to School team from the Sonoma County Bicycle Coalition, or through internal City tracking of proposed crossings enhancements.

At the direction of the Bicycle and Pedestrian Advisory Board, staff will use TDA Article 3 funds to install various school safety improvements that will increase safety for those walking and bicycling to school, specifically at schools that are likely to see an increase in student population due to the upcoming school closures in the Santa Rosa City Schools District.

At direction of the Bicycle and Pedestrian Advisory Board, City staff examined the current school closure proposals and its associated schedule. While the school(s) that displaced students will transfer to is unknown, the City is able to use reasonable information to make assumptions about which schools will likely absorb students. In addition, City staff was able to review existing project lists from school walking audits to determine where the limited TDA Article 3 funding could be used for improvements. These projects and their benefiting school are listed below. Completion of these projects are contingent on design review by the Santa Rosa Fire Department to ensure adequate emergency access and response times.

Exhibit B contains MTC's required findings for Allocation of TDA Article 3 funds. Staff confirmed that the City is in compliance with, or will comply with, all required findings detailed in Exhibit B.

FISCAL IMPACT

Approval of this action does not have a fiscal impact on the General Fund and no matching funds are required with these projects. The requested funds will be placed into JL Key 17057. The funds are formula funds distributed by MTC through SCTA.

ENVIRONMENTAL IMPACT

Pursuant to CEQA Guidelines Section 15378, the proposed action is not a "project" subject to the California Environmental Quality Act (CEQA) because it does not have a potential for resulting in either a direct physical change in the environment or a reasonably foreseeable indirect physical change in the environment. In the alternative, the proposed action is exempt from CEQA pursuant to CEQA Guidelines Section 15061(b)(3) because it can be seen with certainty that there is no possibility that the project may have a significant effect on the environment. Allocating funding for this project does not require environmental clearance. Additionally, pedestrian and bicycle enhancement projects of this scale would be exempt because they will occur on existing City roadways.

BOARD/COMMISSION/COMMITTEE REVIEW AND RECOMMENDATIONS

On February 26, 2024, the Bicycle and Pedestrian Advisory Board (BPAB) passed a motion to allocate \$251,210 of FY 2025/2026 TDA 3 funds for the installation of various school active transportation improvements that will improve walking and bicycling conditions at select schools that may see an increase in student population due to upcoming school closures in the Santa Rosa City Schools District.
