

## CITY OF SANTA ROSA NOTICE OF PUBLIC HEARING

CONSIDERATION OF AN ORDINANCE OF THE COUNCIL OF THE CITY OF SANTA ROSA AMENDING TITLE 9 OF THE SANTA ROSA CITY CODE BY REPEALING CHAPTER 9-24 PERTAINING TO ADMINISTRATIVE ENFORCEMENT OF COVID-19 PUBLIC HEALTH ORDERS IN ITS ENTIRETY; BY ADDING A NEW CHAPTER 9-24 PERTAINING TO THE INSPECTION, MAINTENANCE AND REGISTRATION OF REAL PROPERTIES WHICH EXIST AS UNMAINTAINED VACANT LOTS OR WHICH CONTAIN VACANT OR ABANDONED BUILDINGS; AND BY AMENDING SECTION 18-20.302.4 OF THE SANTA ROSA CITY CODE

Notice is hereby given that a public hearing will be conducted by the City Council on Tuesday February 13, 2024, at or after 5:00 p.m. The purpose of the public hearing will be to receive public comment and recommendations prior to the City Council acting on the consideration of the ordinance and associated implementation program pertaining to the inspection, maintenance, and registration of real properties which exist as unmaintained vacant lots or which contain vacant or abandoned buildings.
