8.2 LMC EMBLEM SANTA ROSA - CONCEPT DESIGN REVIEW - 3575 MENDOCINO AVE - DR22-015

> BACKGROUND: Concept Design Review for a proposed development of a 260-unit, market-rate, for-rent development on 10.9 acres consisting of 13 20-unit buildings and a central clubhouse with community amenities, including a fitness center, and leasing/property management offices. A total of 379 covered and surface parking spaces would be provided at a ratio of 1.48:1 spaces per unit. The parking spaces will be 119 surface, 130 carports and 130 tuck under garage spaces. Proposal includes construction of a 1.0-acre private park fronting Mendocino Avenue. The request for the Design Review
