Capital Improvement Program


- Capital Improvement Program (CIP) – A five-year financial plan for the maintenance and expansion of public infrastructure
- CIP projects must be consistent with the General Plan
 - California law requires planning agencies to review planned public works projects for conformity with the General Plan

Capital Improvement Program Projects

Fiscal Year 2025-2026

- New CIP Projects for Fiscal Year 2025-2026 include the following improvements:
 - Transportation infrastructure
 - Regional and local water and wastewater infrastructure, maintenance
 - Fire infrastructure
 - City parks infrastructure, planning

CIP Projects Implement General Plan Goals and Policies



The project will replace aging sewer and water pipes on Claremont Dr., Carvel Dr., Del Mar Dr., Easton Dr. and Rocklin Dr.

Action 5-9.22: Maintain existing levels of wastewater service by preserving and improving infrastructure, including replacing sewer mains, as necessary.

Action 5-9.3: Maintain water, wastewater, and recycled water system integrity and capacity by continuing to prioritize maintenance and preserve funding for maintenance, rehabilitation, and replacement of existing infrastructure.



Action 2-4.3: Create environments with safe, connected streets, sidewalks, and bicycle facilities that include shade trees to establish a pleasant streetscape.

Goal 3-2: Provide a safe and accessible active and public transportation network that emphasizes active transportation connections and service to Equity Priority Areas and Areas of Change.


Action 3-2.13: Ensure that there are no physical barriers to bicyclists or pedestrians as they cross high traffic roadways at intersections of Class I or Class IV facilities through improvements such as crosswalks and beacon lights.

Implementation of SS4A program in compliance with the DOT National Roadway Safety Strategy.

Sample projects: curb extensions, compliance with AB 413/CA Daylighting Law, speed control measures, pilot safety projects

Action 3-2.16: Continue to upgrade curb ramps and other pedestrian infrastructure in compliance with the Americans with Disabilities Act.

CIP Projects Implement General Plan Goals and Policies



UIF, Measure DD, Gas Tax 2107 Contingencies Project IDs 2520, 2521, 2522

Policy 3-2.1: Ensure that the active transportation network remains in good condition by maintaining facilities, tracking the state of infrastructure, and managing the network in a way that serves all users.

Action 3-2.11: Support pedestrians and bicyclists by incorporating their needs and interests into regular planning activities for all City projects, including, at a minimum, any project on the Capital Improvements Project list.

Goal 5-1: Minimize community exposure to seismic and geologic hazards.

Action 5-1.8: Retrofit and harden water storage facilities, wastewater conveyance, electricity transmission lines, roadways, water detention facilities, levees, and other utilities near the Rodgers Creek Fault.

Repair to Reservoirs Project ID 2482

Action 5-9.3: Maintain water, wastewater, and recycled water system integrity and capacity by continuing to prioritize maintenance and preserve funding for maintenance, rehabilitation, and replacement of existing infrastructure.

Action 5-9.8: Evaluate the City's long-term water supply strategies, including development of new sources of water supply, enhanced water efficiency programs, and implementation of appropriate growth-control measures, if deemed necessary by the City.

Action 5-9.10: Implement the Water Supply Alternatives Plan to mitigate potential impacts of climate change, drought, and natural or human-caused catastrophic events by enhancing water supply resiliency and reliability.



Action 3-7.29: Continue to implement existing clean energy and green practices such as capturing energy from digestion of wastewater solids and implementing energy-efficient capital improvement projects, such as the 2022 ultraviolet disinfection system upgrade at the Laguna Treatment Plant.

Policy 5-9.4: Ensure that adequate wastewater capacity is available to serve existing and future needs of the city.





Action 6-7.31: Provide continuous maintenance, renovation, and rehabilitation of the City's parklands to maintain the long-term viability of the parks system and enhance quality of life of all community members.

Policy 6-7.5: Ensure high-quality design and construction of new parks and park improvements that are sensitive to the natural environment, respectful of historic structures and important cultural landscapes, responsive to the needs of people of all ages and abilities, and compatible with surrounding land uses.

Environmental Review

California Environmental Quality Act (CEQA)

- Not subject to CEQA, §15378
 - Not a project
- Future Environmental Review
 - Each of the projects will undergo environmental review before being implemented

The Planning and Economic Development Department recommends that the Planning Commission, by Resolution:

- Find that the 18 new projects included in the fiscal year 2025-2026 Capital Improvement Program are consistent with the City of Santa Rosa 2050 General Plan.
