Sequoia Gardens Mobile Home Park is a 55 and older community with 191 housing units located at the confluence of Santa Rosa and Piner Creeks on Fulton Rd. Some residents are elderly, living on fixed incomes and have mobility or transportation impediments that contribute to isolation and food insecurity.

Additionally, we have many able, active, resourceful neighbours who enjoy serving our community and love to garden. We envision a thriving, productive community garden cared for by neighbours contributing wholesome food sources for park residents. Our community garden spaces are accessible individual lot areas located around the park where we endeavour to enhance community relationships and support resident nutrition through access to exercise, relationships and fresh produce grown in our community garden spaces.

We estimate our gardens will initially benefit 50 households and impact the entire park with uplift and engaging community relationships. We intend to share our learning, best practices and resources with any neighbours desiring to expand garden spaces in a like manner in their cur de sacs.

The proposed community garden was presented at our May 2023 HOA board meeting that included interested resident participation. The matter was discussed openly and was enthusiastically approved. The minutes are distributed in our monthly park newsletter and accessible to all park residents. No park Managers objected and onsite management voiced support.

We begin with a sub committee of the HOA, whose charge is expressly to support the community garden project. The committee members serve a two year + rotation starting with 15 volunteers and three garden lot spaces secured. Committee roles include a rotating chair/lead, secretary and treasurer. The committee is responsible for planning, implementation, budgeting, communications, garden labor and volunteer coordination. Our intention is to use collaborative decision making with all active participants. Major decisions will be presented at the HOA monthly (all inclusive) meeting prior to taking action.

Individual residents have donated a portion of their lot space for the gardens and water is master metered. All garden areas are easily accessed via a common walking path with planned seating available. Food will be grown and harvested by volunteer gardeners and shared with community members. Neighbours tend the soil, maintain the garden, grow plant starts, socialise, harvest, distribute food, serve on a committee or simply receive the bounty and enjoy the beauty.

A common area inside the club house adjacent to the kitchen can be used for produce distribution. All garden activity notifications for residents will occur through our park email distribution lists, private community Facebook page, the Quail Call monthly news magazine, word of mouth and posting on our community bulletin

board. We encourage and welcome any park resident to participate at a level that is suitable to them.

Ongoing maintenance will consist of weeding, soil amendments, small minor repairs, planting, seasonal garden upkeep, tool and safety supply maintenance. Committee members with resident volunteers will manage these needs.

Our community garden will serve as a model for sustainability using locally sourced and recycled materials, compost, timed drip irrigation, mulching, minimal/no till, reduced fossil fuel emissions by providing at home access to fresh produce and hand tool use. We foresee increased education and resources for the community such as battery and e-waste recycling, composting, food waste reduction, small scale solar use for garden appliances such as drip irrigation or fountains, water conservation, Santa Rosa Creek clean up and protection, a tool library and more.

The well being, security and safety of our residents is priority number one! All county health and safety protocols will be followed and enforced with necessary supplies provided. Liability waivers relieving management, property owner groups, the Garden Committee and HOA will be required prior to any participation. Additionally, community education and agreements shall be secured in writing regarding safe lifting, mobility needs, tool use, decision making, privacy, shared resources and the like.

Utilising numerous online and local community garden and supply resources we researched costs and anticipated needs. We pooled our collective experience to determine an evidence based estimate of costs and ongoing expenses. Pledges of money, seeds, soil amendments, materials, labor, tools, time, transportation, fuel and expertise have been received from numerous enthusiastic neighbours.
