DRAFT BUSINESS RECRUITMENT PLAN: TARGET INDUSTRIES- 2026

PREFACE AND METHODOLOGY

The City of Santa Rosa Economic Development Strategic Plan (adopted April 2024) establishes goals for business recruitment and attraction:

1. Increase the number of medium and large businesses in key industries
2. Create a business retention and expansion strategy for existing industry,
3. create a comprehensive outreach and marketing plan to attract identified key industries
4. Align efforts with Sonoma County to create a tandem approach to attraction efforts

Sections E.3 and E.9 of the Santa Rosa Economic Development Strategy Implementation Plan layout strategies for these goals including:

E.3. Conduct a Business Gap Analysis, Existing Cluster Industry Analysis, and Key Emerging Industry Sectors Analysis

E.9. Create a Comprehensive Outreach and Marketing Plan (aka “Business Recruitment Plan”.) to Attract Identified Key Industries

For determining which industries to attract, grow and recruit to Santa Rosa staff evaluated conditions related to gaps and opportunities in the market and analyzed data related but not limited to existing industry and sector strengths and weaknesses, current and projected labor market trends, education and degree attainment/issuance, state and regional economic goals and target industries.

This data was gathered and reviewed at the Metropolitan Statistical Area (MSA) level using the State of California Employment Development Department (EDD) for calculating MSA’s.

On July 21, 2023, the Office of Management and Budget (OMB) announced an update to statistical area delineations based on the application of the new standards to data from the 2020 Census. Micropolitan Statistical Areas have at least one urban cluster of at least 10,000 but less than 50,000 population, plus adjacent territory that has a high degree of social and economic integration with the core as measured by commuting ties.

The City of Santa Rosa falls into the “Santa Rosa-Petaluma MSA” statistical area.

The Current Employment Statistics (CES) program is a Federal-State cooperative effort in which monthly surveys are conducted to provide estimates of employment, hours, and earnings based on payroll records of business establishments. The CES survey is based on approximately 119,000 businesses and government agencies representing approximately 629,000 individual worksites throughout the United States.

 - State strategy includes this as part of Anchor (Healthcare)
 - Supports equity and local community resilience goals
- Relevant NAICS:

6. Childcare and Early Childhood Education

- Rationale:
 - Designated Anchor Sector by California and a BAJFC regional priority
 - Strong local degree attainment from SSU (Early Childhood Studies)
 - Direct impact on workforce participation (especially women)
- Relevant NAICS:

7. Tourism, Culinary Arts, and Experience Economy

 - High employment in Leisure & Hospitality

 - State strategy: Strengthen sector under Tourism, Arts, Food & Ag
