RESOLUTION OF THE COUNCIL OF THE CITY OF SANTA ROSA APPROVING THE FIFTH AMENDMENT TO PROFESSIONAL SERVICES AGREEMENT NUMBER F002029 WITH JESSICA RASMUSSEN INCREASING COMPENSATION BY \$20,000 FOR A TOTAL AMOUNT NOT TO EXCEED \$320,680

WHEREAS, the City first contracted with Jessica Rasmussen for art programming and project management in 2019; and

WHEREAS, on July 12, 2022, the City Council approved the Third Amendment to Professional Services Agreement with Jessica Rasmussen revising the Scope of Services, increasing Compensation and extending Time of Performance for continuing services; and

WHEREAS, the Fifth Amendment to the Professional Services Agreement with Jessica Rasmussen will allow for the continuation of services necessary to fulfil the current Public Art Program workplan element of the Economic Development Division, as well as the PED Work Plan Priority reflected in the City Council Work Plan to implement the Public Art Strategic Plan (Strategy 4i); and

WHEREAS, Jessica Rasmussen has taken on additional, higher-level duties and responsibilities to support the Public Art Program with vacancy of the Arts & Culture Coordinator position; and

WHEREAS, Jessica Rasmussen has provided quality service to the Public Art Program since 2014, meeting program needs for a variety of programs and projects including, community art programs, public art projects, cultural events, marketing and outreach for related programs and projects, and support to the Art in Public Places Committee, particularly related to implementing the Public Art Strategic Plan; and

WHEREAS, the Public Art Program desires to continue to receive services from Jessica Rasmussen, as their familiarity with the Public Art Program and the objectives of the City Council and Planning and Economic Development Work Plans will be beneficial to the City of Santa Rosa; and

WHEREAS, in the absence of additional FTEs, the continued utilization of contracted services is imperative to implement the current Public Art Program Strategic Plan; and

WHEREAS, the City now desires to extend these services for the Economic Development Division through June 30, 2024, and increase compensation in the amount of \$20,000 for a total not to exceed amount of \$320,680; and

WHEREAS, funds for this expenditure are included in the Fiscal Year 2023-2024 Public Art Fund and SRTBIA Fund budgets with no impact to the General Fund.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Santa Rosa approves the Fifth Amendment to Professional Services Agreement Number F002029 with Jessica Rasmussen, attached to this resolution as Exhibit A and made a part of herein increasing compensation in the amount of \$20,000 for a total contract amount not to exceed \$320,680.
