

**FIRST AMENDMENT
TO PROFESSIONAL SERVICES AGREEMENT NUMBER F002076A
WITH AVENU INSIGHTS & ANALYTICS, LLC**

This First Amendment to Agreement number **F002076A**, dated November 19, 2019 is made as of this _____ day of _____, 2023, by and between the City of Santa Rosa, a municipal corporation ("City"), and Avenu Insights & Analytics, LLC ("Consultant").

RECITALS

- A. City and Consultant entered into the Agreement for Consultant to provide revenue and audit and consulting services listed in the exhibit attached to the Agreement.
- B. City and Consultant now desire to amend the Agreement for the purpose of extending the time for performance by executing the two one-year extensions in the current agreement and increasing compensation by \$853,020.

AMENDMENT

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. Section 2. Compensation

Exhibit A, Section 2(c) is amended to increase the compensation payable to Consultant under the Agreement by \$853,020 to read as follows:

"Notwithstanding any other provision in this Agreement to the contrary, the total maximum compensation to be paid for the satisfactory accomplishment and completion of all tasks set forth above shall in no event exceed one million four hundred fifty-three thousand, twenty dollars and no cents (\$1,453,020). The City's Chief Financial Officer is authorized to pay all proper claims from various charge numbers."

2. Section 7. Notices

The parties to receive notice in Section 7 of the Agreement are amended as follows:

3. Section 12. Time of Performance

The last sentence of Section 12 is amended to read as follows:

"The services described herein shall be provided during the period, or in accordance with the schedule, set forth in Exhibit A. Consultant shall complete all the required services and tasks and complete and tender all deliverables to the reasonable satisfaction of City, not later than September 30, 2026."

All other terms of the Agreement shall remain in full force and effect.
