RECITALS

- A. City and Consultant entered into the Agreement for Consultant to provide services in the inRESPONSE Mental Health Program (Program) to benefit the residents of the City by providing mental health assistance and substance abuse support through a broad behavioral health response model.
- B. City and Consultant now desire to amend the Agreement for the purpose of adding additional funding related to increased staffing levels and hours of operation and extending the time of performance.

<u>AMENDMENT</u>

NOW, THEREFORE, the parties agree to amend the Agreement as follows:

1. Section 2. Compensation

Exhibit B and Exhibit B-1 are supplemented by Exhibit B-2 to this AmendmentSection 2(c) is amended to increase the compensation payable to Consultant under the Agreement by \$2,361,496.00 to read as follows:

"Notwithstanding any other provision in this Agreement to the contrary, the total maximum compensation to be paid for the satisfactory accomplishment and completion of all tasks set forth above shall in no event exceed the sum of three million four hundred sixty three thousand five hundred sixty three dollars and no cents (\$3,463,563.00). The City's Chief Financial Officer is authorized to pay all proper claims from various charge numbers."

2. Section 12. Time of Performance

The last sentence of Section 12 is amended to read as follows:

"Consultant shall complete all the required services and tasks and complete and tender all deliverables to the reasonable satisfaction of City, not later than January 31, 2027."

All other terms of the Agreement shall remain in full force and effect.
