My name is Kerry Bodine, and I live on Sunrise Avenue on the hill above the Flamingo. My husband Brian Haven is here, too.

Our personal concerns fall into two categories:

- 1. First and foremost is quality of life. We moved to Santa Rosa from San Francisco several years ago because of the peace and quiet afforded by the city and our property, in particular. We spend a significant amount of time outside in our backyard and we're concerned that the peace and quiet we currently enjoy will be forever marred by noise from pickleball activity.
- 2. Our second concern is the resale value of our home. We're making continued investments in our property, and we're concerned that when it eventually comes time for us to sell, our property value will not reflect its full potential because of noise from the pickleball. As we all know, lower property values negatively impact homeowners and deprive the county of related tax income.

Of course, we're concerned not just for us, but also for the quality of life and property values of all of our neighbors.

For these reasons, we ask you to VOTE NO on the Flamingo's pickleball application.

Should you decide to allow pickleball, we have the following requests:

- Please require the Flamingo to provide, and only allow, noise dampening paddles.
  - Yes, many Pickleball players have their own paddles and probably prefer to play with them. But we are balancing the needs of all sides here. Requiring play with noise dampening paddles is a small sacrifice for people who are coming into our peaceful neighborhood for recreation purposes.
  - We also ask that there be a stipulation for the Flamingo to not only to provide these types of paddles, but also to upgrade them to whatever is state-of-the-art on a jointly determined regular basis.
- We ask the city to assess the noise level on the hill behind the Flamingo prior to granting a permit.
  - Sound moves in every direction, not just parallel with the ground.
  - Sound also travels faster in warmer air, so sound waves are refracted upward, away from the ground.
  - At our home, we very clearly hear the music played at the Flamingo, and we are not confident that ANY of the proposed noise tarps will have any dampening effect on the pickleball noise refracted up the hill towards our home.
- Please require the Flamingo to enforce a ban on foul language at the courts.

- Please ban tournaments. Should you decide to allow tournaments, please put specific stipulations in the permit that will limit tournament activity and the related noise nuisance.
  - These stipulations might include a limit on the number of people allowed on the courts at any given time
  - o And/or the frequency and duration of tournaments.
- We ask that all verbal commitments by the Flamingo be written stipulations of the permit so that they're legally obligated to keep their word — and that if they don't, the surrounding neighbors have recourse to pause pickleball activity until the approved conditions are met.
  - Last week Laura told us that they have no plans for pickleball tournaments for the upcoming year.
    - Point A: We hope to enjoy the sanctuary of our home for longer than the next year.
    - Point B: Even if Laura made and kept a promise that they won't hold tournaments, what's to stop the next person in her role from making a different decision?
- We ask for a written stipulation regarding customer service standards for the surrounding community.
  - When this came up at last week's meeting, Laura mentioned that some of the neighbors have her direct number.
    - We shouldn't have to have Laura's direct number to have our concerns addressed.
  - Part A of this customer service request is for the Flamingo to publish and publicize email addresses and phone numbers that we can use to report concerns and violations.
  - **Part B** is a stipulated, reasonable response time to complaints made when the Flamingo is out of compliance.
  - Part C is sufficient customer service training for all Flamingo employees on how to handle incoming communication from neighbors.
- We plead with you to provide legal recourse if the noise requirements are not met.

Wrapping up — My husband and I are both business owners, and we understand Yang's desire to provide a service to their customers. But Yang didn't purchase a business property in an industrial area of the city or in an open field. They made a *business decision* to purchase a property that's nestled in a quiet residential community. And wanting to serve their customers doesn't give them carte blanche to do it in a way that harms our neighbors.

Whatever you decide, please ensure that our neighbors have recourse in this matter — and that you don't hand Yang a blank check if pickleball is approved. We thank you for your time.

I would like to submit the following comment regarding "The Club at Flamingo" application for converting two (2) tennis courts into eight (8) pickleball courts.

The Flamingo Resort is not located in wine country surrounded by vineyards — it is located in a residential area, surrounded by homes. I live next door to The Flamingo Resort.

The application to create 8 pickleball courts needs to be carefully considered in light of how playing pickleball has created noise pollution in every residential area where pickleball courts are located.

Contrary to tennis equipment, playing pickleball is done with a hard plastic ball and a hard paddle. Compared to playing tennis for which the average decibel has been measured at 40 dBA, the average pickleball decibel (both indoor and outdoor) has been measured at about 70 dBA.

Allowing pickleball to be played outdoors for 10 hours during summer months (9 am - 7 pm) is too many hours — the longest that residential area based pickleball courts should be allowed to remain open is 8 hours. And having 8 pickleball courts within a residential area is excessive — the total should be reduced to 4 courts.

Residents need to be protected from the constant, loud, pop-pop-pop-pop noise

created by pickleball playing, and any business that wants to create outdoor pickleball courts within a residential area should be required to soundproof them with sound barriers.

### Good morning,

My name is Mark Hulsman and I live with my wife, Jami at 2170 Rogers Way. Our undeveloped property is five feet away from the proposed pickle ball courts and our home is 120 feet away from the proposed courts. This has been our family home for the past seventy years.

There is no other property in the City of Santa Rosa, or Sonoma County for that matter that has a proposed pickle ball court use permit so close to an existing residential property. Approval of this project would be setting a precedent.— apply that we have the solutions.

Oakmont was the first in Santa Rosa to put pickle ball on tennis courts near residential property. There were only four courts allowed in any tennis complex. The distance from the courts to the first residential property line is forty feet. There is another forty feet to the actual residence which was on a bluff above the tennis courts for a total of eighty feet.

Again, I reiterate Flamingo Hotel wants to put eight pickleball courts five feet away from our property line. Given the criteria of the City of Santa Rosa, when development of this property happens, it will be multi-family units at least two stories tall with a set back of 20 feet.

Before the cease and desist order was initiated, only four courts were used and one court was used as a tented weight/workout area. The pickleball started at 7:00 in the morning, and was sporadically played until the evening during the week. On the weekends the courts were used from 7:00 until sunset.

Even though our home is 120 feet away from the pickle ball courts, we were subjected to the continual "pop, pop, pop, of pickleball play. The noise level would be much worse for any future units closer to our property line.

The Flamingo intends to install sound tarps to reduce the noise of play. Yet, given what they call the shadow box effect of where noise travels, it is good to protect maybe the first floor of a residence, but does not protect the second floor of a residence. In essence, noise travels more than lateral, it travels upwards and over the barrier.

The sound test that was conducted by the City was done when there was minimal play going on at the courts in that there was family play which does not reflect was the actual sound level would be when there is tournament play. There is quite a difference between casual players and league play.

Having researched noise levels that accompany pickle ball play, the problem is not so much with the decibels of the sound, but with the high pitched "hertz". What this means is that the human ear is more accustomed to hearing high pitched sounds rather than the low based sounds. This is what most people complain about. The tarps do nothing to reduce this type of noise. I got this type of information from an article written by Mark Dent on 7/21/2023 in The Hustle .com The next article is from Mr. Unetich who advises and works with USA Pickle ball and according to him, pickle ball paddles vibrate at a high pitch of a thousand to two thousand "hertz" and this causes the "pop, pop, pop" sound. The next article is from PaddleTek.com (game on). According to them tarps and paddle boards have to be the newest on the market in order to bring decibel levels and high pitched frequency levels down to a point where they are not noticed.

Also, the comments from various magazines that were propickle ball that the best way to avoid complaints is a buffer zone of anywhere of 100 feet, and in some cases, 250 feet from the nearest pickle ball court to residences. For instance, a Torrence California municipal code enacted in 2024 requires 250 feet from court to residence. There are more of these types of articles if you take a look at noiseawareness.org. which has many articles regarding Pickle ball lawsuits, neighborhood complaints and setbacks.

7 Bring in pages 1,2, +3

We suggest the paddles proposed by the Flamingo should be mandated for all players who play on the courts. Health club guests and hotel guests are not allowed to bring their own weights or athletic equipment to play with, why should paddles be any different if they are only going to cater to these people. This should not be an issue, since they told us at our neighborhood meeting that is was not their intention to have any tournaments.

We have a long history of being neighbors with the Flamingo Hotel, and there has been some history that has involved broken promises and deaf ears to the issues of noise, repair and replacement of required acoustic fencing, and wayward tennis balls. The representatives at the neighborhood meeting suggested that they would "check in" with us every six months to see how things were going. We do not feel that is a reliable way to monitor this process.

We feel if there is any approval of any part of what they are proposing should fall under a conditional or provisional approval. What the solutions could be is:

1>No pickle ball allowed.

- 2>Re-stripe the current tennis courts #1 and #2 to run north and south as they were supposed to be, then one of the courts closest to the clubhouse have four courts of pickle ball with complete sound mitigation so that none of the neighbors would hear any of the noise generated.
- 3>The only people allowed to play on the courts would be the members of the health club. It would take the whole idea of using pickle ball tournaments to sell hotel rooms out of the equation.

- 1) MHHC converted one tennis court to Pickleball during the Covid months, without requesting a Change of Use.
- 2) I began my quest for information regarding the change from tennis to Pickleball in December 2022. Code Enforcement Case # CE22-1216.

It was at this time I assumed the change to Pickleball was not temporary.

- 3) Members of MHHC had been informed that the club was going to install lights and convert the top three courts to Pickleball in conjunction with the hotel to have large scale tournaments sponsored by The Flamingo.
- 4) The members interested in tennis where informed that USTA & the Women's League play would no longer be available because it requires 3 courts to field an event.
- 5) The application for the changes of now two courts do not address the increased parking that will be required by the club to handle such large events.

Two courts converted to 8 Pickle Ball courts would allow for 32 players playing simultaneously. With a field of players 3 times or more that number

in a rotating tournament format.

6) According to one study by a retired engineer, a solid pickleball hit registers 70 decibels of noise, as much as a vacuum cleaner. The sound

test done by Code Enforcement could not possible equate to the sounds during the full use of 8 courts.

After receiving a notice in the mail, I reached out to Monet for more information. She provided all the documents submitted by the applicant, including a "Project Narrative" and a "Noise Letter," as well as documents from prior permit activity involving the health club.

In a letter dated March 18th, the owner of JMC Lighting claims the installation of an 11.1-foot high noise barrier at the Flamingo's proposed Pickleball courts would reduce noise levels emanating into the adjacent residential areas by 15 dBA. Other attachments included with this letter go on to contradict this claim.

The letter claims a study done with the JMC Acoustic Sound Barrier curtains in Walnut Creek demonstrates these barriers would have the same effect at the Flamingo. However, the two cases are non-congruent. The barriers alone do not account for all of the reduction in noise level. Proximity plays a major role. Measurements taken from residential areas at the Walnut Creek site were 99 feet or more from the Pickleball courts. The courts at the Flamingo appear to be only about 10 feet from where offending sound level measurements were taken.

In fact, the role of distance on sound dampening is clearly laid out by other attachments sent with the JMC letter. From the last page: "Even at 100 feet, with consideration for equipment and sound barriers, the level could be about 52 dBa," This aligns very closely with the readings taken in Walnut Creek.

This attachment also points out how doubling the distance will reduce the level by 6dB. The inverse is also true, the level will increase 6dB each time the distance is halved. Using JMC's numbers, sound levels 25 feet from a court with these barriers installed is expected to be 58dBA. At the Flamingo property line, this would be over 60dBA!

Further, it seems there is not enough data available for anyone to make an informed decision. The two-page letter from JMC, as obtained by the city, appears to be missing at least one page. Monet has informed me this is the way the letter was submitted to the city. Also, the Walnut Creek study does not take the topology of the surrounding neighborhood into account. It is unreasonable to assume a 10-12 foot tall barrier would serve equally for a single story dwelling on a level grade and a two story apartment up a hill.

I am opposed to this permit being issued based on the lack of clear information.

I took dBA measurements at different locations, near and far, while the activity of pickleball was taking place. The City of Santa Rosa enforces ambient base noise level criteria using a sound level meter.

"Ambient noise" is the all-encompassing noise associated with a given environment, being usually a composite of sounds from many sources near and far. For the purpose of this chapter, ambient noise level is the level obtained when the noise level is averaged over a period of 15 minutes without inclusion of noise from isolated, identifiable sources, at the location and time of day near that at which a comparison is to be made.
