#### RECOMMENDATION

It is recommended that the Council, by resolution, appoint Teresa Stricker to the position of City Attorney and approve the Employment Agreement – City Attorney. It is further recommended that the Council introduce an ordinance for first reading only, waiving full reading of the text, establishing the salary of the City Attorney in the amount of \$24,500 per month or \$294,000 annually effective November 6, 2023.

#### **EXECUTIVE SUMMARY**

After a nationwide recruitment, selection process and candidate interviews, the City Council intends to appoint Teresa Stricker as the City Attorney. Council reached satisfactory terms and conditions for an employment contract.

#### BACKGROUND

City Attorney Sue Gallagher retired from her position as City Attorney effective July 28, 2023.

Teresa Stricker has agreed to the terms and conditions set forth in the Employment Agreement – City Attorney attached as Exhibit A to the Resolution. The term of the agreement will commence on November 6, 2023, and continue until terminated as provided in the contract.

The City Charter requires that the compensation for the salary of the City Attorney be established by ordinance. A Proposed Ordinance is included for introduction by the Council.

#### <u>ANALYSIS</u>

As legally allowed under the Brown Act and appropriate as a personnel matter, the City Council held discussions and interviews for the City Attorney position in Closed Session

over the past few months. The City was fortunate to have a number of highly qualified applicants.

With over two decades in municipal law, Teresa Stricker has demonstrated her proficiency in addressing a wide spectrum of legal matters crucial to the effective functioning of our City.

Ms. Stricker's recent roles, including City Attorney for the City of San Pablo and prior service as City Attorney for Richmond, showcase her ability to provide strategic counsel to city officials, manage complex litigation, and optimize legal operations. Her tenure as Partner and Managing Partner at Renne Public Law Group highlights her leadership skills and her proactive approach to advising public agencies on a multitude of municipal challenges. Ms. Stricker's proven ability to navigate intricate legal landscapes, foster collaboration, and provide practical solutions aligns seamlessly with Santa Rosa's vision for continued growth and development.

## FISCAL IMPACT

The proposed City Attorney salary of \$294,000 for the current fiscal year is approximately \$30,000 higher than the current budgeted amount for the position. This increase will be offset in the current fiscal year by position vacancies in the City Attorney Office and will be incorporated into future adopted budgets.

## **ENVIRONMENTAL IMPACT**
